STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-ONE

AN ACT Increasing Certain Motor Vehicle Registration Fees.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 29, § 152, amended. The first 2 sentences of section 152 of Title 29 of the Revised Statutes are amended to read as follows:

Whoever transfers the ownership or discontinues the use of a registered motor vehicle or trailer and applies to the Secretary of State for registration of another motor vehicle or trailer in the same calendar year shall be entitled to a certificate of registration permitting the use of number plates of the proper class of registration thereon upon payment of a transfer fee of \$2\$5, provided the fee is the same as that of the former vehicle. If the fee for the vehicle to be registered is greater, he shall pay in addition to the transfer fee of \$2\$5 the difference between the fee paid by him for the vehicle first registered and the fee for the vehicle to which the transfer is to be made.

Sec. 2. R. S., T. 29, § 242, sub-§ 1, ¶ A, amended. The first sentence of paragraph A of subsection 1 of section 242 of Title 29 of the Revised Statutes is amended to read as follows:

Used for the conveyance of passengers, \$15 \$20.

- Sec. 3. R. S., T. 29, § 244, sub-§ 1, repealed. Subsection 1 of section 244 of Title 29 of the Revised Statutes, as amended by section 8 of chapter 245 of the public laws of 1967, is repealed.
- Sec. 4. R. S., T. 29, § 244, amended. The 2nd paragraph of section 244 of Title 29 of the Revised Statutes is amended to read as follows;

The minimum fee shall never be less than \$2 \$5. The maximum fee for all farm trailers, whether semitrailers or 4-wheeled type, equipped with pneumatic tires, shall be \$2 \$5 for each trailer when the said trailers are used and to be used by farmers for the sole and exclusive purpose of transporting their own farm products, crops, fertilizers and farm tools and utensils and subject to the further conditions and limitations that

- A. No such load so transported shall at any time exceed 4 tons; and
- B. No such load shall be transported a distance greater than 20 miles from the point of origin to the point of destination.
- Sec. 5. R. S., T. 29, § 245, amended. The last paragraph of section 245 of Title 29 of the Revised Statutes is amended to read as follows:

Semitrailer \$5 \$15 each.

Sec. 6. R. S., T. 29, § 245-A, amended. The last sentence of the first paragraph of section 245-A of Title 29 of the Revised Statutes, as enacted by section 1 of chapter 448 of the public laws of 1967, is amended to read as follows:

The fee for such plate shall be \$5 \$15 for each registration year, or portion thereof, for the number of years of valid use from the year of issue to the end of the semipermanent plate program; and there shall be no refund of payment of such fee except as provided in section 154.

Sec. 7. R. S., T. 29, § 245-A, amended. The 2nd paragraph of section 245-A of Title 29 of the Revised Statutes, as enacted by section 1 of chapter 448 of the public laws of 1967, is amended to read as follows:

Provisions of this section shall not prohibit the succeeding Legislatures from increasing the base fee of \$5 \$15 per year, or portion thereof; and registrants shall make additional payment to the State, under any new rate enacted, for the remaining period of plates originally issued, to the end of the semipermanent plate program.

Sec. 8. R. S., T. 29, § 246, amended. The first 2 paragraphs of section 246 of Title 29 of the Revised Statutes, as amended, are further amended to read as follows:

With each application for registration of a motor truck, truck-tractor or tractor shall be paid an annual registration fee graduated as follows when equipped with pneumatic tires:
