SENATE AMENDMENT "A" to S. P. 622, L. D. 1805, Bill, "AN ACT to Provide for the Taxation of Pulpwood and Longs in Place Where Situated."

Amend said Bill by inserting after the enacting clause, the following:

'Sec. 1. R. S., T. 36, § 603, sub-§ 1, ¶ C, additional.
Subsection 1 of section 603 of Title 36 of the Revised Statutes is amended by adding a new paragraph C to read as follows:

C. For the purposes of this subsection,
"personal property employed in trade, in
the erection of buildings or vessels, or
in the mechanic arts" shall not include
pulpwood and logs. '

Further amend said Bill by striking out everything after the amending clause in section 2 and inserting in place thereof the following:

'A-1. Pulpwood and logs, excepting pulpwood and
logs in the possession of a transportation company
and in transit.'

Further amend said Bill by renumbering sections 1 and 2 to be sections 2 and 3

Statement of Fact

It is the intent of this amendment to correct possible conflict so that there will be no question that pulpwood and logs are to be taxed where situated and that such property as is merely bought by a company but not moved is not in transit and,

therefore taxable where situated or taxable where the owner resides if actually in transit.
