STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-ONE

RESOLVE, to Apportion One Hundred and Fifty-one Representatives Among the Several Counties, Cities, Towns, Plantations and Unorganized Territory of the State.

Apportionment of Representatives to the Legislature.

WHEREAS, in accordance with Article IV, Part 1, Sections 2 and 3 of the Constitution of Maine, the Legislature has ascertained the number of inhabitants of the State to be 993,663; now, therefore, be it

RESOLVED: That for the 106th Legislature to and including 1982:

Androscoggin.

The County of Androscoggin, having a population of 91,279, shall choose 14 Representatives; and the unit base number for said county being 6,520, said Representatives shall be apportioned as follows:

First Androscoggin District:

The First Androscoggin District shall consist of the municipalities of Durham, Lewiston and Sabbatus, having a combined population of 44,724, and shall choose 7 Representatives.

Second Androscoggin District:

The Second Androscoggin District shall consist of the municipalities of Auburn and Poland, having a combined population of 26,166, and shall choose 4 Representatives.

Third Androscoggin District:

The Third Androscoggin District shall consist of the municipality of Lisbon, having a population of 6,544, and shall choose I Representative.

Fourth Androscoggin District:

The Fourth Androscoggin District shall consist of the municipalities of Livermore, Mechanic Falls, Minot and Turner, having a combined population of 6,968, and shall choose I Representative.

Fifth Androscoggin District:

The Fifth Androscoggin District shall consist of the municipalities of Greene, Leeds, Livermore Falls and Wales, having a combined population of 6,877, and shall choose I Representative.

Aroostook.

The County of Aroostook, having a population of 94,078, shall choose 14 Representatives, and the unit base number for said county being 6,719, said Representatives shall be apportioned as follows:

First Aroostook District:

The First Aroostook District shall consist of the municipalities of Ashland, Eagle Lake, Fort Kent, Frenchville, Grand Isle, Madawaska, Masardis, Portage Lake, St. Agatha, St. Francis, Stockholm and Van Buren, the Plantations of Caswell, Cyr, Garfield, Nashville, New Canada, Oxbow, St. John, Wallagrass and Winterville, the Unorganized Township of Connor, and all unorganized territory within said County not included in any other Representative District within said county, having a combined population of 26,528, and shall choose 4 Representatives.

Second Aroostook District:

The Second Aroostook District shall consist of the municipalities of Castle Hill, Mapleton, New Sweden, Perham, Wade, Washburn and Woodland, and the Plantation of Westmanland, having a combined population of 6,631, and shall choose I Representative.

Third Aroostook District:

The Third Aroostook District shall consist of the municipalities of Caribou, Easton, Fort Fairfield, Limestone, Mars Hill, Presque Isle and Westfield, having a combined population of 40,787, and shall choose 6 Representatives.

Fourth Aroostook District:

The Fourth Aroostook District shall consist of the municipalities of Blaine, Bridgewater, Chapman, Dyar Brook, Hersey, Littleton, Ludlow, Merrill, Monticello, Oakfield and Smyrna, the Plantations of E., Hammond and Moro, and the Unorganized Townships of T. 11, R. 4, W.E.L.S., T. 10, R. 4. (Squapan), T. 10, R. 3, W.E.L.S., T. 9, R. 5, W.E.L.S., T. 9, R. 4, W.E.L.S., T. 9, R. 3, W.E.L.S., T. D., R. 2, T. 8, R. 5, W.E.L.S., T. 8, R. 4 (St. Croix), T. 8, R. 3, W.E.L.S., T. C., R. 2, T. 7, R. 5, W.E.L.S., T. 7, R. 4, (Webbertown) and T. 7, R. 3 (Dudley), having a combined population of 6,710, and shall choose 1 Representative.

Fifth Aroostook District:

The Fifth Aroostook District shall consist of the municipalities of Amity, Bancroft, Benedicta, Crystal, Hainesville, Hodgdon, Houlton, Island Falls, Linneus, Orient, Sherman and Weston, the Plantations of Cary, Glenwood, Macwahoc and Reed, and the Unorganized Townships of T. 4, R. 3, W.E.L.S., T. A., R. 2, T. 3, R. 4, W.E.L.S., T. 3, R. 3, W.E.L.S., T. 3, R. 2 (Forkstown), Silver Ridge, T. 2, R. 4, T. 1, R. 5, W.E.L.S., T. 1, R. 4 (Upper Molunkus and North Yarmouth Academy Grant), and T. A., R. 5 (Molunkus), having a combined population of 13,422, and shall choose 2 Representatives.

Cumberland.

The County of Cumberland, having a population of 192,528, shall choose 29 Representatives; and the unit base number for said county being 6,639, said Representatives shall be apportioned as follows:

First Cumberland District:

The First Cumberland District shall consist of the municipalities of Brunswick, Freeport, Gray, Harpswell, New Gloucester, Pownal and Yarmouth, having a combined population of 34.932, and shall choose 5 Representatives.

Second Cumberland District:

The Second Cumberland District shall consist of the municipalities of Cumberland, Falmouth, North Yarmouth, Ward I, Precinct 3, Ward I, Precinct 4, Ward I, Precinct 5, Ward 4, Precinct I, Ward 5, Precinct I, Ward 6, Precinct I and Ward 6, Precinct 2 of the City of Portland, having a combined population of 33,468, and shall choose 5 Representatives.

Third Cumberland District:

The Third Cumberland District shall consist of the following Wards and Precincts in the City of Portland: Ward 1, Precinct 1, Ward 1, Precinct 2, Ward 2, Precinct 1, Ward 2, Precinct 2, Ward 3, Precinct 1, Ward 4, Precinct 2, and Ward 5, Precinct 2, having a combined population of 38,696, and shall choose 6 Representatives.

Fourth Cumberland District:

The Fourth Cumberland District shall consist of the municipalities of Gorham and Westbrook, and Ward 3, Precinct 2 in the City of Portland, having a combined population of 27,005, and shall choose 4 Representatives.

Fifth Cumberland District:

The Fifth Cumberland District shall consist of the municipalities of Cape Elizabeth, Scarboro and South Portland, having a combined population of 38,985, and shall choose 6 Representatives.

Sixth Cumberland District:

The Sixth Cumberland District shall consist of the municipality of Windham, having a population of 6,593, and shall choose I Representative.

Seventh Cumberland District:

The Seventh Cumberland District shall consist of the municipalities of Baldwin, Bridgton, Casco, Harrison, Naples, Otisfield, Raymond, Sebago and Standish, having a combined population of 12,849, and shall choose 2 Representatives.

Franklin.

The County of Franklin, having a population of 22,444, shall choose 3 Representatives; and the unit base number for said county being 7,481, said Representatives shall be apportioned as follows:

First Franklin District:

The First Franklin District shall consist of the municipalities of Chesterville, Farmington, New Sharon and Temple, having a combined population of 7,392, and shall choose I Representative.

Second Franklin District:

The Second Franklin District shall consist of the municipalities of Jay and Wilton, having a combined population of 7,756, and shall choose I Representative.

Third Franklin District:

The Third Franklin District shall consist of all municipalities, plantations and unorganized territory within said county not included in any other Representative district within said county, having a combined population of 7,296, and shall choose I Representative.

Hancock.

The County of Hancock, having a population of 34,590, shall choose 5 Representatives; and the unit base number for said county being 6,918, said Representatives shall be apportioned as follows:

First Hancock District:

The First Hancock District shall consist of the municipalities of Brooklin, Brooksville, Castine, Cranberry Isles, Deer Isle, Sedgwick, Stonington, and Tremont, and the Plantation of Long Island, having a combined population of 6,999, and shall choose I Representative.

Second Hancock District:

The Second Hancock District shall consist of the municipalities of Bucksport, Dedham, Orland, Otis, Penobscot and Verona, having a combined population of 6,931, and shall choose I Representative.

Third Hancock District:

The Third Hancock District shall consist of the municipalities of Blue Hill, Ellsworth, Surry and Trenton, having a combined population of 6,985, and shall choose I Representative.

Fourth Hancock District:

The Fourth Hancock District shall consist of the municipalities of Bar Harbor, Mount Desert and Southwest Harbor, having a combined population of 7,032, and shall choose I Representative.

Fifth Hancock District:

The Fifth Hancock District shall consist of the municipalities of Amherst, Aurora, Eastbrook, Franklin, Gouldsboro, Hancock, Lamoine, Mariaville, Sorrento, Sullivan, Waltham and Winter Harbor, the Plantations of Great Pond, No. 33, and Osborn, and all unorganized territory within said county, having a combined population of 6,643, and shall choose I Representative.

Kennebec.

The County of Kennebec, having a population of 95,247, shall choose 14 Representatives; and the unit base number for said County being 6,803, said Representatives shall be apportioned as follows:

First Kennebec District:

The First Kennebec District shall consist of the municipalities of Vassalboro, Waterville and Winslow, having a combined population of 28,109, and shall choose 4 Representatives.

Second Kennebec District:

The Second Kennebec District shall consist of the municipality of Gardiner, having a population of 6,685, and shall choose I Representative.

Third Kennebec District:

The Third Kennebec District shall consist of the municipalities of Albion, Benton, China, Clinton and the Unorganized Township of Unity, having a combined population of 6,651, and shall choose I Representative.

Fourth Kennebec District:

The Fourth Kennebec District shall consist of the municipalities of Chelsea, Pittston, Randolph and Windsor, having a combined population of 6,550, and shall choose I Representative.

Fifth Kennebec District:

The Fifth Kennebec District shall consist of the municipalities of Augusta, Oakland and Sidney, having a combined population of 26,799, and shall choose 4 Representatives.

Sixth Kennebec District:

The Sixth Kennebec District shall consist of the municipalities of Belgrade, Readfield and Winthrop, having a combined population of 6,895, and shall choose I Representative.

Seventh Kennebec District:

The Seventh Kennebec District shall consist of the municipalities of Farmingdale, Hallowell and Manchester, having a combined population of 6,568, and shall choose I Representative.

Eighth Kennebec District:

The Eighth Kennebec District shall consist of the municipalities of Fayette, Litchfield, Monmouth, Mount Vernon, Rome, Wayne and West Gardiner, having a combined population of 6,990, and shall choose I Representative.

Knox.

The County of Knox, having a population of 29,013, shall choose 4 Representatives; and the unit base number for said county being 7,253, said Representatives shall be apportioned as follows:

First Knox District:

The First Knox District shall consist of the municipalities of Camden, Hope, Rockland and Rockport, having a combined population of 15,187, and shall choose 2 Representatives.

Second Knox District:

The Second Knox District shall consist of the municipalities of Cushing, Friendship, Isle au Haut, North Haven, Owls Head, St. George, South Thomaston and Vinalhaven, and the Plantation of Matinicus Isle, having a combined population of 6,776, and shall choose I Representative.

Third Knox District:

The Third Knox District shall consist of the municipalities of Appleton, Thomaston, Union, Warren and Washington, having a combined population of 7,050, and shall choose I Representative.

Lincoln:

The County of Lincoln, having a population of 20,537, shall choose 3 Representatives; and the unit base number for said county being 6,846, said Representatives shall be apportioned as follows:

First Lincoln District:

The First Lincoln District shall consist of the municipalities of Jefferson, Nobleboro, Waldoboro and Whitefield, the Plantations of Monhegan and Somerville, and the Unorganized Township of Hibberts Gore, having a combined population of 6,628, and shall choose I Representative.

Second Lincoln District:

The Second Lincoln District shall consist of the municipalities of Boothbay, Boothbay Harbor, Southport, Westport and Wiscasset, having a combined population of 7,079, and shall choose I Representative.

Third Lincoln District:

The Third Lincoln District shall consist of the municipalities of Alna, Bremen, Bristol, Damariscotta, Dresden, Edgecomb, Newcastle and South Bristol, having a combined population of 6,830, and shall choose I Representative.

Oxford.

The County of Oxford, having a population of 43,457, shall choose 7 Representatives; and the unit base number for said county being 6,208, said Representatives shall be apportioned as follows:

First Oxford District:

The First Oxford District shall consist of the municipalities of Rumford and Mexico. having a combined population of 13,672, and shall choose 2 Representatives.

Second Oxford District:

The Second Oxford District shall consist of the municipalities of Buckfield, Canton, Dixfield, Hartford, Peru and Sumner, having a combined population of 6,041, and shall choose I Representative.

Third Oxford District:

The Third Oxford District shall consist of the municipalities of Brownfield, Denmark, Fryeburg, Hiram, Lovell, Porter, Stoneham, Stow, Sweden and the Unorganized Townships of Albany, Batchelder's Grant and Mason, having a combined population of 6,054, and shall choose I Representative.

Fourth Oxford District:

The Fourth Oxford District shall consist of the municipalities of Norway, Oxford and Waterford, having a combined population of 6,247, and shall choose I Representative.

Fifth Oxford District:

The Fifth Oxford District shall consist of the municipalities of Greenwood, Hebron, Paris and West Paris, having a combined population of 6,052, and shall choose I Representative.

Sixth Oxford District:

The Sixth Oxford District shall consist of the municipalities of Andover, Bethel, Byron, Gilead, Hanover, Newry, Roxbury, Upton and Woodstock, the Plantations of Lincoln and Magalloway, and all other unorganized territory within said county not included within any other voting district within said county, having a combined population of 5,391, and shall choose I Representative.

Penobscot.

The County of Penobscot, having a population of 125,393, shall choose 19 Representatives; and the unit base number for said county being 6,600, said Representatives shall be apportioned as follows:

First Penobscot District:

The First Penobscot District shall consist of the municipality of Bangor, having a population of 33,168, and shall choose 5 Representatives.

Second Penobscot District:

The Second Penobscot District shall consist of the municipalities of Chester, East Millinocket, Lee, Lincoln, Medway, Millinocket, Patten, Stacyville, Woodville, the Plantation of Mt. Chase, and all unorganized territory within said county not included within any other voting district within said county, having a combined population of 19,660, and shall choose 3 Representatives.

Third Penobscot District:

The Third Penobscot District shall consist of the municipalities of Burlington, Edinburg, Enfield, Howland, Lagrange, Lowell, Mattawamkeag, Maxfield, Passadumkeag, Springfield and Winn, the Plantations of Carroll, Drew, Grand Falls, Lakeville, Prentiss, Seboeis and Webster, the unorganized township of Kingman, and the Indian Island Voting District, having a combined population of 6,414, and shall choose I Representative.

Fourth Penobscot District:

The Fourth Penobscot District shall consist of the municipalities of Bradley, Greenbush, Greenfield, Hudson, Milford and Old Town, having a combined population of 13,085, and shall choose 2 Representatives.

Fifth Penobscot District:

The Fifth Penobscot District shall consist of the municipalities of Brewer, Clifton, Eddington, Holden, Orrington, Orono and Veazie, having a combined population of 26,979, and shall choose 4 Representatives.

Sixth Penobscot District:

The Sixth Penobscot District shall consist of the municipalities of Carmel, Dixmont, Etna, Glenburn, Hampden, Hermon, Kenduskeag, Levant and Newburgh, having a combined population of 13,021, and shall choose 2 Representatives.

Seventh Penobscot District:

The Seventh Penobscot District shall consist of the municipalities of Alton, Bradford, Charleston, Corinna, Corinth, Dexter, Exeter, Garland, Newport, Plymouth and Stetson, and the unorganized township of Argyle, having a combined population of 13,066, and shall choose 2 Representatives.

Piscataquis.

The County of Piscataquis, having a population of 16,285, shall choose 3 Representatives; and the unit base number for said county being 5,423, said Representatives shall be apportioned as follows:

First Piscataquis District:

The First Piscataquis District shall consist of the municipalities of Dover-Foxcroft, Sangerville and Sebec, having a combined population of 5,610, and shall choose 1 Representative.

Second Piscataquis District:

The Second Piscataquis District shall consist of the municipalities of Atkinson, Bowerbank, Brownville, Medford, Milo, Monson and Willimantic, the plantations of Barnard, Elliottsville and Lakeview, and the Unorganized Township of Orneville, having a combined population of 5,467, and shall choose I Representative.

Third Piscataquis District:

The Third Piscataquis District shall consist of the municipalities of Abbott, Greenville. Guilford, Parkman, Shirley and Wellington, the Plantations of Blanchard and Kingsbury, and all other unorganized territory within said county not included within any other voting district within said county, having a combined population of 5,208, and shall choose I Representative.

Sagadahoc.

The County of Sagadahoc, having a population of 23,452, shall choose 4 Representatives; and the unit base number for said county being 5,863, said Representatives shall be apportioned as follows:

First Sagadahoc District:

The First Sagadahoc District shall consist of the municipalities of Bath, Phippsburg and West Bath, having a combined population of 11,737, and shall choose 2 Representatives.

Second Sagadahoc District:

The Second Sagadahoc District shall consist of the municipalities of Bowdoinham and Topsham, having a combined population of 6,316, and shall choose I Representative.

Third Sagadahoc District:

The Third Sagadahoc District shall consist of the municipalities of Arrowsic, Bowdoin, Georgetown, Richmond and Woolwich, and the Unorganized Township of Perkins, having a combined population of 5,392, and shall choose I Representative.

Somerset.

The County of Somerset, having a population of 40,597, shall choose 6 Representatives; and the unit base number for said county being 6,766, said Representatives shall be apportioned as follows:

First Somerset District:

The First Somerset District shall consist of the municipalities of Fairfield, Skowhegan and Smithfield, having a combined population of 13,712, and shall choose 2 Representatives.

Second Somerset District:

The Second Somerset District shall consist of the municipalities of Canaan, Hartland and Pittsfield, having a combined population of 6,592, and shall choose I Representative.

Third Somerset District:

The Third Somerset District shall consist of the municipalities of Cornville, Madison and Norridgewock, having a combined population of 6,865, and shall choose I Representative.

Fourth Somerset District:

The Fourth Somerset District shall consist of the municipalities of Athens, Bingham, Cambridge, Detroit, Harmony, Moscow, Palmyra, Ripley and St. Albans, and the Plantation of Brighton, having a combined population of 6,516, and shall choose I Representative.

Fifth Somerset District:

The Fifth Somerset District shall consist of the municipalities of Anson, Embden, Jackman, Mercer, Moose River, New Portland, Solon and Starks, the Plantations of Caratunk, Dennistown, Highland, Pleasant, The Forks and West Forks, and all unorganized territory within said county, having a combined population of 6,812, and shall choose I Representative.

Waldo.

The County of Waldo, having a population of 23,328, shall choose 4 Representatives; and the unit base number for said county being 5,832, said Representatives shall be apportioned as follows:

First Waldo District:

The First Waldo District shall consist of the municipality of Belfast, having a population of 5,957, and shall choose I Representative.

Second Waldo District:

The Second Waldo District shall consist of the municipalities of Burnham, Freedom, Liberty, Lincolnville, Montville, Palermo, Searsmont and Unity, having a combined population of 5,624, and shall choose I Representative.

Third Waldo District:

The Third Waldo District shall consist of the municipalities of Belmont, Brooks, Frankfurt, Jackson, Monroe, Morrill, Northport, Swanville, Thorn-dike, Troy and Waldo, having a combined population of 5,912, and shall choose I Representative.

Fourth Waldo District:

The Fourth Waldo District shall consist of the municipalities of Islesboro, Prospect, Searsport, Stockton Springs and Winterport, having a combined population of 5,835, and shall choose I Representative.

Washington.

The County of Washington, having a population of 29,859, shall choose 5 Representatives; and the unit base number for said county being 5,972, said Representatives shall be apportioned as follows:

First Washington District:

The First Washington District shall consist of the municipalities of Addison, Beals, Beddington, Centerville, Cherryfield, Columbia, Columbia Falls, Deblois, Harrington, Milbridge, Northfield, Steuben, Wesley and Whitney-ville, having a combined population of 5,533, and shall choose I Representative.

Second Washington District:

The Second Washington District shall consist of the municipalities of Jonesport, Jonesboro, Roque Bluffs, Machias, Machiasport and Marshfield, having a combined population of 5,482, and shall choose I Representative.

Third Washington District:

The Third Washington District shall consist of the municipalities of Charlotte, Cooper, Crawford, Cutler, Dennysville, East Machias, Lubec, Meddybemps, Pembroke and Whiting, the Plantations of No. 14 and No. 21, and the Unorganized Townships of T. 18, E. D., T. 19, E. D., Edmunds, Marion and Trescott, having a combined population of 5,788, and shall choose I Representative.

Fourth Washington District:

The Fourth Washington District shall consist of the municipalities of Calais and Baileyville, having a combined population of 6,211, and shall choose I Representative.

Fifth Washington District:

The Fifth Washington District shall consist of the municipalities of Alexander, Eastport, Perry, Princeton, Robbinston, the Unorganized Townships of Baring, T. 18, M.D., T. 19, M.D., T. 24, M.D., T. 25, M.D., T. 29, M.D., T. 30, M.D., T. 31, M.D., T. 36, M.D., T. 37, M.D., T. 26, E. D., T. 42, M.D., T. 43, M.D., T. 27, E.D. and all municipalities, plantations and unorganized territory in said county to the north of these and not included within any other Representative District in said county, having a combined population of 6,845, and shall choose I Representative.

York.

The County of York, having a population of 111,576, shall choose 17 Representatives; and the unit base number for said county being 6,563, said Representatives shall be apportioned as follows:

First York District:

The First York District shall consist of the municipalities of Arundel,

Biddeford Old Orchard Beach and Saco, having a combined population of 38,387, and shall choose 6 Representatives.

Second York District:

The Second York District shall consist of the municipalities of Eliot, Kittery and York, having a combined population of 20,215, and shall choose 3 Representatives.

Third York District:

The Third York District shall consist of the municipalities of Berwick, North Berwick, South Berwick and Wells, having a combined population of 13,296, and shall choose 2 Representatives.

Fourth York District:

The Fourth York District shall consist of the municipalities of Acton, Lebanon, Newfield, Sanford and Shapleigh, having a combined population of 19,509, and shall choose 3 Representatives.

Fifth York District:

The Fifth York District shall consist of the municipalities of Alfred, Buxton, Dayton, Kennebunk, Kennebunkport and Lyman, having a combined population of 13,562, and shall choose 2 Representatives.

Sixth York District:

The Sixth York District shall consist of the municipalities of Cornish, Hollis, Limerick, Limington, Parsonsfield and Waterboro, having a combined population of 6,607, and shall choose I Representative.
