**RESOLVE, Dividing the State into 31 Districts for the Choice of Senators.**

---

---

**Apportionment of Senators to the Legislature.**

**Resolved:** That for the 106th Legislature to and including 1982, the following districts are established and shall each choose one Senator:

**First Senatorial District:**

The First Senatorial District shall consist of the municipalities of Acton, Berwick, Eliot, Kittery, Lebanon, Newfield, South Berwick, North Berwick and York, having a combined population of 32,201.

**Second Senatorial District:**

The Second Senatorial District shall consist of the municipalities of Alfred, Arundel, Kennebunk, Kennebunkport, Lyman, Sanford, Shapleigh and Wells, having a combined population of 32,022.

**Third Senatorial District:**

The Third Senatorial District shall consist of the municipalities of Biddeford, Dayton and Saco, having a combined population of 32,207.

**Fourth Senatorial District:**

The Fourth Senatorial District shall consist of the municipality of Scarborough in the County of Cumberland; the municipalities of Brownfield, Denmark, Fryeburg, Gilead, Hiram, Lovell, Norway, Porter, Stoneham, Stow, Sweden and Waterford, and the unorganized townships of Albany, Batchelder's Grant and Mason, in the County of Oxford; and the municipalities of Buxton, Cornish, Hollis, Limerick, Old Orchard Beach, Parsonsfield and Waterboro in the County of York, having a combined total population of 32,441.

**Fifth Senatorial District:**

The Fifth Senatorial District shall consist of all municipalities, plantations and unorganized territory in the County of Oxford not included within the boundaries of the Fourth Senatorial District, having a combined population of 32,941.

**Sixth Senatorial District:**

The Sixth Senatorial District shall consist of the municipalities of Mechanic Falls, Minot and Poland, in the County of Androscoggin; the municipalities of Baldwin, Bridgton, Casco, Gray, Harrison, Naples, New Gloucester, Otisfield, Raymond, Sebago, Standish and Windham in the County of Cumberland; and the municipality of Limington in the County of York, having a combined population of 31,385.

**Seventh Senatorial District:**

The Seventh Senatorial District shall consist of the municipalities of Cumberland, Falmouth, Gorham and Westbrook, having a combined population of 32,670.

**Eighth Senatorial District:**

The Eighth Senatorial District shall consist of the municipalities of Cape Elizabeth and South Portland, and Ward 1, Precinct 3, Ward 1, Precinct 4, and Ward 1, Precinct 5 of the City of Portland, having a combined population of 32,078.

**Ninth Senatorial District:**

The Ninth Senatorial District shall consist of Ward 1, Precinct 1, Ward 1, Precinct 2, Ward 4, Precinct 1, Ward 5, Precinct 1, Ward 6, Precinct 1 and Ward 6, Precinct 2, in the City of Portland, having a combined population of 32,062.

**Tenth Senatorial District:**

The Tenth Senatorial District shall consist of Ward 2, Precinct 1, Ward 2, Precinct 2, Ward 3, Precinct 1, Ward 3, Precinct 2, Ward 4, Precinct 2, and Ward 5, Precinct 2 in the City of Portland, having a combined population of 32,116.

**Eleventh Senatorial District:**

The Eleventh Senatorial District shall consist of the municipalities of Brunswick, Durham, Freeport, Harpswell, North Yarmouth, Pownal and Yarmouth, having a combined population of 31,829.

**Twelfth Senatorial District:**

The Twelfth Senatorial District shall consist of the municipality of Auburn and Ward 1, Precinct 1, Ward 6, Precinct 1 and Ward 6, Precinct 2 in the City of Lewiston, having a combined population of 32,543.

**Thirteenth Senatorial District:**

The Thirteenth Senatorial District shall consist of the municipality of Lew-

iston, except those Wards and Precincts included in the Twelfth Senatorial District, having a combined population of 33,387.

**Fourteenth Senatorial District:**

The Fourteenth Senatorial District shall consist of the municipalities of Greene, Leeds, Livermore, Livermore Falls, Turner and Wales, in the County of Androscoggin, and the municipalities of Belgrade, Fayette, Gardiner, Litchfield, Monmouth, Mt. Vernon, Readfield, Rome, Vienna, Wayne, West Gardiner and Winthrop in the County of Kennebec, having a combined population of 31,303.

**Fifteenth Senatorial District:**

The Fifteenth Senatorial District shall consist of the municipalities of Oakland, Waterville, Winslow and Vassalboro, having a combined population of 31,644.

**Sixteenth Senatorial District:**

The Sixteenth Senatorial District shall consist of the municipalities of Augusta, Chelsea, Farmingdale, Hallowell, Manchester and Sidney, having a combined population of 31,927.

**Seventeenth Senatorial District:**

The Seventeenth Senatorial District shall consist of the municipalities of Lisbon and Sabattus in the County of Androscoggin, and all municipalities and unorganized territory in the County of Sagadahoc, having a combined population of 31,677.

**Eighteenth Senatorial District:**

The Eighteenth Senatorial District shall consist of all municipalities and unorganized territory within the County of Lincoln with the exception of Waldoboro; the municipalities of Albion, Benton, China, Clinton, Pittston, Randolph and Windsor, and the unorganized township of Unity, in the County of Kennebec; the municipality of Washington, in the County of Knox; and the municipalities of Freedom, Palermo and Unity, in the County of Waldo, having a combined population of 31,518.

**Nineteenth Senatorial District:**

The Nineteenth Senatorial District shall consist of the municipality of Waldoboro, in the County of Lincoln, and all municipalities and plantations in the County of Knox with the exception of Washington, having a combined population of 31,436.

**Twentieth Senatorial District:**

The Twentieth Senatorial District shall consist of the municipalities of Dixmont, Etna, Newport, Stetson and Plymouth, in the County of Penobscot; the municipalities of Detroit, Palmyra and Pittsfield, in the County of Somerset; and all municipalities in the County of Waldo not included within the Eighteenth Senatorial District, having a combined population of 31,553.

**Twenty-First Senatorial District**

The Twenty-First Senatorial District shall consist of all municipalities, plantations and unorganized territory within the County of Franklin and all municipalities, plantations and unorganized territory in the County of Somerset not included within the Twentieth or Twenty-Second Senatorial Districts, having a combined population of 31,423.

**Twenty-Second Senatorial District:**

The Twenty-Second Senatorial District shall consist of the municipalities of Corinna, Dexter and Exeter, in the County of Penobscot; and of the municipalities of Cambridge, Canaan, Cornville, Fairfield, Harmony, Hartland, Madison, Mercer, Norridgewock, Ripley, St. Albans, Skowhegan and Smithfield, in the County of Somerset, having a combined population of 31,665.

**Twenty-Third Senatorial District:**

The Twenty-Third Senatorial District shall consist of the municipalities of Carmel, Charleston, Corinth, Garland, Glenburn, Hudson, Kenduskeag, Levant and Old Town, in the County of Penobscot; and of all municipalities, plantations and unorganized territory in the County of Piscataquis, having a combined population of 32,573.

**Twenty-Fourth Senatorial District:**

The Twenty-Fourth Senatorial District shall consist of the municipalities of Eagle Lake, Ft. Kent, Frenchville, Grand Isle, Limestone, Madawaska, St. Agatha, St. Francis and Van Buren, and the plantations of Allagash, Caswell, Hamlin, New Canada, St. John, Wallagrass and Winterville, and the unorganized territories of T. 17, R. 3; T. 16, R. 4; T. 15, R. 5; T. 14, R. 6; T. 13, R. 7; T. 12, R. 7; T. 11, R. 7; T. 10, R. 7; T. 9, R. 7 and all unorganized territory in Aroostook County to the west of these, having a combined population of 32,594.

**Twenty-Fifth Senatorial District:**

The Twenty-Fifth Senatorial District shall consist of the municipalities of Caribou, Easton, Fort Fairfield, Mars Hill, Presque Isle and Washburn, having a combined population of 31,824.

**Twenty-Sixth Senatorial District:**

The Twenty-Sixth Senatorial District shall consist of all municipalities, plantations and unorganized territory in the County of Aroostook not included within the Twenty-Fourth or Twenty-Fifth Senatorial Districts; and of the municipalities of Mattawamkeag and Winn, the plantations of Drew, Prentiss and Webster, and the unorganized township of Kingman, in the County of Penobscot, having a combined population of 31,775.

**Twenty-Seventh Senatorial District:**

The Twenty-Seventh Senatorial District shall consist of all municipalities, plantations and unorganized territory in the County of Penobscot not included within the Twentieth, Twenty-Second, Twenty-Third, Twenty-Sixth,

Twenty-Eighth or Twenty-Ninth Senatorial Districts, having a combined population of 32,100.

**Twenty-Eighth Senatorial District:**

The Twenty-Eighth Senatorial District shall consist of the municipalities of Bangor, except for Ward 7, Precinct 2 thereof, and Hermon, having a combined population of 32,787.

**Twenty-Ninth Senatorial District:**

The Twenty-Ninth Senatorial District shall consist of the municipalities of Brewer, Hampden, Newburgh, Orono, Orrington and Veazie, and Ward 7, Precinct 2 of the City of Bangor, having a combined population of 31,832.

**Thirtieth Senatorial District:**

The Thirtieth Senatorial District shall consist of the County of Hancock, except the municipalities of Gouldsboro and Winter Harbor, having a combined population of 31,815.

**Thirty-First Senatorial District:**

The Thirty-First Senatorial District shall consist of the County of Washington; and the municipalities of Gouldsboro and Winter Harbor, in the County of Hancock, having a combined population of 32,197.
