RESOLVE, Dividing the State into 33 Districts for the Choice of Senators.

Apportionment of Senators for the Legislature.

Resolved: That for the 106th Legislature to and including 1982, the following districts are established and shall each choose one Senator:

First Senatorial District:

The First Senatorial District shall consist of the municipalities of Eliot, Kittery, North Berwick, South Berwick, Wells and York, having a combined total population of 30,375.

Second Senatorial District:

The Second Senatorial District shall consist of the municipalities of Arundel, Biddeford, Kennebunk, Kennebunkport and Lyman, having a combined total population of 29,975.

Third Senatorial District:

The Third Senatorial District shall consist of the municipalities of Acton, Alfred, Berwick, Cornish, Lebanon, Limerick, Limington, Newfield, Parsonsfield, Sanford, Shapleigh and Waterboro, having a combined total population of 30,704.

Fourth Senatorial District:

The Fourth Senatorial District shall consist of the municipalities of Buxton, Dayton, Hollis, Old Orchard Beach and Saco, in the County of York, and the municipality of Scarboro, in the County of Cumberland, having a combined total population of 30,168.

Fifth Senatorial District:

The Fifth Senatorial District shall consist of the municipalities of Bethel, Brownfield, Buckfield, Canton, Denmark, Dixfield, Greenwood, Hanover, Hartford, Hebron, Fryeburg, Lovell, Newry, Norway, Oxford, Paris, Peru, Stoneham, Stow, Sumner, Sweden, Waterford, West Paris and Woodstock, the unorganized townships of Albany, Batchelder's Grant, Mason and Milton, having a combined total population of 29,559.

Sixth Senatorial District:

The Sixth Senatorial District shall consist of the municipalities of Baldwin, Casco, Cumberland, Falmouth, Gray, Harrison, Naples, New Gloucester, Otisfield, Raymond, Sebago and Windham, having a combined total population of 29,490.

Seventh Senatorial District:

The Seventh Senatorial District shall consist of the municipalities of Gorham, Standish and Westbrook, and Ward 6, Precinct 2 of the City of Portland, having a combined total population of 29,845.

Eighth Senatorial District:

The Eighth Senatorial District shall consist of the municipalities of Cape Elizabeth and South Portland, having a combined total population of 31,140.

Ninth Senatorial District:

The Ninth Senatorial District shall consist of Ward I, Precinct I, Ward I, Precinct 2, Ward I, Precinct 3, Ward I, Precinct 4, Ward I, Precinct 5, Ward 2, Precinct I, Ward 2, Precinct 2 and Ward 3, Precinct I of the City of Portland, having a combined total population of 30,344.

Tenth Senatorial District:

The Tenth Senatorial District shall consist of Ward 3, Precinct 2, Ward 4, Precinct 1, Ward 4, Precinct 2, Ward 5, Precinct 1, Ward 5, Precinct 2 and Ward 6, Precinct 1 of the City of Portland, having a combined total population of 30,332.

Eleventh Senatorial District:

The Eleventh Senatorial District shall consist of the municipalities of Brunswick, Freeport, Harpswell, North Yarmouth, Pownal and Yarmouth, having a combined total population of 30,565.

Twelfth Senatorial District:

The Twelfth Senatorial District shall consist of the municipalities of Auburn, Mechanic Falls, Minot and Poland, having a combined population of 29,278.

Thirteenth Senatorial District:

The Thirteenth Senatorial District shall consist of Ward 1, Precinct 1, Ward 1, Precinct 2, Ward 2, Precinct 1, Ward 2, Precinct 2, Ward 3, Precinct 1, Ward 3, Precinct 2, Ward 4, Precinct 1, Ward 5 and Ward 6, Precinct 1 in the City of Lewiston, having a combined total population of 29,411.

Fourteeenth Senatorial District:

The Fourteenth Senatorial District shall consist of the municipalities of Durham, Lisbon, Sabattus and Wales, and Ward 4, Precinct 2, Ward 6, Precinct 2, Ward 7, Precinct 1, and Ward 7, Precinct 2 of the City of Lewiston, and of the municipalities of Bowdoin, Bowdoinham, and Topsham, in the County of Sagadahoc, having a combined total population of 29,655.

Fifteenth Senatorial District:

The Fifteenth Senatorial District shall consist of the municipalities of Greene, Leeds, Livermore, Livermore Falls and Turner, in the County of Androscoggin, and of the municipalities of Farmingdale, Fayette, Gardiner, Litchfield, Manchester, Monmouth, Wayne, West Gardiner and Winthrop, in the County of Kennebec, having a combined total population of 30,626.

Sixteenth Senatorial District:

The Sixteenth Senatorial District shall consist of the municipalities of Avon, Carthage, Chesterville, Eustis, Jay, Kingfield, Madrid, Phillips, Rangeley, Temple, Weld and Wilton, the plantations of Coplin, Dallas, Rangeley and Sandy River, and all unorganized territory within the County of Franklin, and of the municipalities of Andover, Byron, Mexico, Roxbury, Rumford and Upton, the plantations of Lincoln and Magalloway, and all unorganized territory within the County of Oxford not included within the Fifth Senatorial District, having a combined total population of 29,203.

Seventeenth Senatorial District:

The Seventeenth Senatorial District shall consist of the municipalities of Farmington, Industry, New Sharon, New Vineyard and Strong, in the County of Franklin; the municipalities of Abbot, Monson, Parkman and Wellington, and the plantations of Blanchard and Kingsbury, in the County of Piscataquis; and the municipalities of Anson, Athens, Bingham, Cambridge, Cornville, Detroit, Embden, Harmony, Hartland, Jackman, Madison, Moose River, Moscow, New Portland, Palmyra, Ripley, St. Albans, Solon and Starks, the plantations of Brighton, Caratunk, Dennistown, Pleasant Ridge, The Forks and West Forks, and all unorganized territory within the County of Somerset, having a combined total population of 29,509.

Eighteenth Senatorial District:

The Eighteenth Senatorial District shall consist of the municipalities of Belgrade, Mount Vernon, Oakland, Readfield, Rome, Sidney, Vienna and Waterville, in the County of Kennebec, and the municipalities of Mercer, Norridgewock and Smithfield, in the County of Somerset, having a combined total population of 29,657.

Nineteenth Senatorial District:

The Nineteenth Senatorial District shall consist of the municipalities of

Augusta, Chelsea, Hallowell, Vassalboro and Windsor, having a combined total population of 30,569.

Twentieth Senatorial District:

The Twentieth Senatorial District shall consist of the municipalities of Alna, Boothbay, Boothbay Harbor, Dresden, Edgecomb, Newcastle, Southport, Westport, Whitefield and Wiscasset, in the County of Lincoln; the municipalities of Pittston and Randolph in the County of Kennebec and the municipalities of Arrowsic, Bath, Georgetown, Phippsburg, Richmond, West Bath and Woolwich, and the unorganized township of Perkins, in the County of Sagadahoc, having a combined total population of 30.573.

Twenty-First Senatorial District:

The Twenty-First Senatorial District shall consist of the municipalities of Bremen, Bristol, Damariscotta, Jefferson, Nobleboro, South Bristol and Waldoboro, and the plantations of Monhegan and Somerville in the County of Lincoln, and the municipalities of Cushing, Friendship, Isle Au Haut, North Haven, Owls Head, Rockland, St. George, South Thomaston, Thomaston, Union, Vinalhaven and Warren, and the plantation of Matinicus Isle, in the County of Knox, having a combined total population of 30,580.

Twenty-Second Senatorial District:

The Twenty-Second Senatorial District shall consist of the municipality of China, in the County of Kennebec; the municipalities of Appleton, Camden, Hope, Rockport and Washington, in the County of Knox; and the municipalities of Belfast, Belmont, Brooks, Burnham, Frankfort, Freedom, Islesboro, Jackson, Knox, Liberty, Lincolnville, Montville, Morrill, Northport, Palermo, Prospect, Searsmont, Searsport, Stockton Springs, Swanville, Thorndike, Troy, Unity and Waldo, in the County of Waldo, having a combined total population of 30,770.

Twenty-Third Senatorial District:

The Twenty-Third Senatorial District shall consist of the municipalities of Albion, Benton, Clinton and Winslow, and the unorganized township of Unity, in the County of Kennebec, and the municipalities of Canaan, Fairfield, Pittsfield and Skowhegan in the County of Somerset, having a combined total population of 30,563.

Twenty-Fourth Senatorial District:

The Twenty-Fourth Senatorial District shall consist of the municipalities of Bucksport, Carmel, Corinna, Dexter, Dixmont, Etna, Exeter, Garland, Hampden, Hermon, Newburgh, Newport, Orland, Orrington, Plymouth and Stetson, in the County of Penobscot, and the municipalities of Monroe and Winterport, in the County of Waldo, having a combined total population of 30,288.

Twenty-Fifth Senatorial District:

The Twenty-Fifth Senatorial District shall consist of Ward I, Ward 2,

Ward 3, Precinct 1, Ward 3, Precinct 2, Ward 4, Precinct 1, Ward 4, Precinct, 2, Ward 5, Ward 7, Precinct 1, and Ward 7, Precinct 2 of the City of Bangor, having a combined total population of 29,529.

Twenty-Sixth Senatorial District:

The Twenty-Sixth Senatorial District shall consist of Ward 6 of the City of Bangor, and the municipalities of Bradley, Brewer, Clifton, Eddington, Holden, Orono, Milford and Veazie, having a combined total population of 30,754.

Twenty-Seventh Senatorial District:

The Twenty-Seventh Senatorial District shall consist of the municipalities of Alton, Bradford, Burlington, Charleston, Chester, Corinth, Edinburg, Enfield, Glenburn, Greenbush, Greenfield, Howland, Hudson, Kenduskeag, Lagrange, Lee, Levant, Lincoln, Lowell, Mattawamkeag, Maxfield, Medway, Old Town, Passadumkeag, Springfield, Winn and Woodville, the plantations of Carroll, Drew, Grand Falls, Lakeville, Prentiss, Seboeis and Webster, the Indian Island Voting District, the unorganized townships of Argyle and Kingman, and the unorganized territory of T. 3, R. 1, N.B.P.P., T. 1, N.D., T. 5, R. 1, N.B.P.P., T. 3, R. 9, T. 2, R. 9, T. 2, R. 8, and T. 1, R. 7 (Mattamiscontis), having a combined total population of 29,743.

Twenty-Eighth Senatorial District:

The Twenty-Eighth Senatorial District shall consist of the municipalities of Amherst, Aurora, Bar Harbor, Blue Hill, Brooklin, Brooksville, Castine, Cranberry Isles, Dedham, Deer Isle, Eastbrook, Franklin, Gouldsboro, Hancock, Lamoine, Mariaville, Mount Desert, Otis, Penobscot, Sedgewick, Sorrento, Southwest Harbor, Stonington, Sullivan, Surry, Swans Island, Tremont, Trenton, Verona, Waltham and Winter Harbor, the plantations of Great Pond, Long Island and Osborne, and all unorganized territory within the County of Hancock, having a combined total population of 20,527.

Twenty-Ninth Senatorial District:

The Twenty-Ninth Senatorial District shall consist of all municipalities, plantations and unorganized territory within the County of Washington, having a combined total population of 29,859.

Thirtieth Senatorial District:

The Thirtieth Senatorial District shall consist of the municipalities of Ashland, Crystal, Eagle Lake, Fort Kent, Frenchville, Hersey, Masardis, St. Francis and Sherman, the plantations of Allagash, Garfield, Moro, Nashville, Oxbow, St. John, Wallagrass and Winterville, and the unorganized townships of T. 7, R. 5, W.E.L.S., T. 8, R. 5, W.E.L.S., T. 9, R. 5, W.E.L.S., T. 13, R. 5, W.E.L.S., T. 14, R. 5, W.E.L.S., T. 15, R. 5, W.E.L.S., T. 16, R. 8, W.E.L.S., and all unorganized territory in the County of Aroostook to the west of these; the municipalities of Atkinson, Bowerbank, Brownville, Dover-Foxcroft, Greenville, Guilford, Medford, Milo, Sangerville, Sebec, Shirley and Willimantic, the plantations of Barnard, Elliottsville, and Lakeview, the unorganized township of Orneville, and all other unorganized territory within the County of Piscataquis; and the municipalities of Patton and Stacyville, the plantation of Mount Chase, and the unorganized townships of T. 3, R. 7, W.E.L.S., T. 3, R. 8, W.E.L.S., and all other unorganized territory in the County of Penobscot to the north of these, having a combined total population of 30,292.

Thirty-First Senatorial District:

The Thirty-First Senatorial District shall consist of the municipalities of Caribou, Castle Hill, Chapman, Easton, Fort Fairfield, Presque Isle and Westfield, the plantation of E, and the unorganized township of Connor, having a combined total population of 29,992.

Thirty-Second Senatorial District:

The Thirty-Second Senatorial District shall consist of the municipalities of Grand Isle, Limestone, Madawaska, Mapleton, New Sweden, Perham, St. Agatha, Stockholm, Van Buren, Wade, Washburn and Woodland, the plantations of Caswell, Cyr, Hamlin, New Canada and Westmanland, and the unorganized territory of T. 16, R. 4, W.E.L.S., T. 16, R. 5, W.E.L.S., T. 16, R. 6, W.E.L.S., T. 17, R. 3, W.E.L.S., T. 17, R. 4, W.E.L.S. and T. 17, R. 5, W.E.L.S., having a combined total population of 30,053.

Thirty-Third Senatorial District:

The Thirty-Third Senatorial District shall consist of the municipalities of Amity, Bancroft, Benedicta, Blaine, Bridgewater, Dyer Brook, Haynesville, Houlton, Island Falls, Linneus, Littleton, Ludlow, Mars Hill, Merrill, Monticello, New Limerick, Oakfield, Orient, Smyrna and Weston, the plantations of Cary, Glenwood, Macwahoc and Reed, the unorganized township of Silver Ridge, and all unorganized territory within the County of Aroostook not included within the Thirtieth, Thirty-First or Thirty-Second Senatorial Districts; and the municipalities of East Millinocket, Millinocket, and the unorganized territory of T. A., R. 8 and R. 9, (Long A), Hopkins Academy Grant, T.A., R. 7, T. 4 and T. 3 (Indian Purchase), Veazie Gore, T. 1, R. 6, W.E.L.S., T. 1, R. 7, (Grindstone), T. 1, R. 8, W.E.L.S., T. 2, R. 6, (Herseytown), T. 2, R. 7 (Soldiertown), and T. 2, R. 8, W.E.L.S., in the County of Penobscot, having a combined total population of 30,649.
