IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-ONE

RESOLVE, Dividing the State into 33 Districts for the Choice of Senators.

Apportionment of Senators to the Legislature.

Resolved: That for the 106th Legislature to and including 1982, the following districts are established and shall each choose one Senator:

First Senatorial District:

The First Senatorial District shall consist of the municipalities of Berwick, Eliot, Kittery, South Berwick, Wells and York, having a combined total population of 31,287.

Second Senatorial District:

The Second Senatorial District shall consist of the municipalities of Biddeford and Saco, having a combined total population of 31,661.

Third Senatorial District:

The Third Senatorial District shall consist of the municipalities of Alfred, Arundel, Kennebunk, Kennebunkport, Old Orchard Beach and Sanford, having a combined total population of 31,555.

Fourth Senatorial District:

The Fourth Senatorial District shall consist of the municipalities of Brownfield, Denmark, Fryeburg, Hiram, Norway, Paris, Porter, Sweden, Stow and Waterford, in the County of Oxford, and the municipalities of Acton, Buxton, Cornish, Dayton, Hollis, Lebanon, Limerick, Limington, Lyman, Newfield, North Berwick, Parsonsfield, Shapleigh and Waterboro, in the County of York, having a combined total population of 30,270.

Fifth Senatorial District:

The Fifth Senatorial District shall consist of the municipalities of Andover, Bethel, Buckfield, Byron, Canton, Dixfield, Gilead, Greenwood, Hanover, Hartford, Hebron, Lovell, Mexico, Newry, Oxford, Peru, Roxbury, Rumford, Stoneham, Sumner, Upton, West Paris and Woodstock, the plantations of Lincoln and Magalloway, and all unorganized territory within the County of Oxford, having a combined total population of 30,260.

Sixth Senatorial District:

The Sixth Senatorial District shall consist of the municipalities of Gorham, Scarboro and Westbrook, having a combined total population of 30,128.

Seventh Senatorial District:

The Seventh Senatorial District shall consist of the municipalities of Cape Elizabeth and South Portland, having a combined total population of 31,140.

Eighth Senatorial District:

The Eighth Senatorial District shall consist of Ward 4, Precinct 1, Ward 4, Precinct 2, Ward 5, Precinct 1, Ward 5, Precinct 2, Ward 6, Precinct 1, and Ward 6, Precinct 2 in the City of Portland, having a combined total population of 30,050.

Ninth Senatorial District:

The Ninth Senatorial District shall consist of Ward 1, Precinct 1, Ward 1, Precinct 2, Ward 2, Precinct 1, Ward 2, Precinct 2, Ward 3, Precinct 1, and Ward 3, Precinct 2 in the City of Portland, having a combined total population of 34,128.

Tenth Senatorial District:

The Tenth Senatorial District shall consist of the municipalities of Baldwin, Bridgton, Casco, Falmouth, Gray, Harrison, Naples, Otisfield, Ward I, Precinct 3, Ward I, Precinct 4, and Ward I, Precinct 5 in the City of Portland, Raymond, Sebago, Standish and Windham, having a combined total population of 29,610.

Eleventh Senatorial District:

The Eleventh Senatorial District shall consist of the municipalities of Brunswick, Cumberland, New Gloucester, North Yarmouth, Pownal and Yarmouth, having a combined total population of 30,139.

Twelfth Senatorial District:

The Twelfth Senatorial District shall consist of the municipalities of Freeport and Harpswell, in the County of Cumberland, and all municipalities and unorganized territory in the County of Sagadahoc, having a combined total population of 30,785.

Thirteenth Senatorial District:

The Thirteenth Senatorial District shall consist of the municipalities of

Auburn, Durham, Mechanic Falls, Minot and Poland, having a combined population of 30,542.

Fourteenth Senatorial District:

The Fourteenth Senatorial District shall consist of Ward I. Precinct I, Ward I, Precinct 2, Ward 2, Precinct I, Ward 2, Precinct 2, Ward 3, Precinct I, Ward 3, Precinct 2, Ward 4, Precinct I, Ward 5, and Ward 6, Precinct I in the City of Lewiston, having a combined total population of 29,411.

Fifteenth Senatorial District:

The Fifteenth Senatorial District shall consist of the municipalities of Greene, Leeds, Ward 4, Precinct 2, Ward 6, Precinct 2, Ward 7, Precinct 1 and Ward 7, Precinct 2 in the City of Lewiston, Lisbon, Livermore, Livermore Falls, Sabattus, Turner and Wales, having a combined total population of 31,326.

Sixteenth Senatorial District:

The Sixteenth Senatorial District shall consist of the municipalities of Belgrade, Fayette, Gardiner, Litchfield, Monmouth, Mount Vernon, Oakland, Readfield, Rome, Sidney, Vassalboro, Vienna, Wayne, Winthrop and West Gardiner, having a combined total population of 28,042.

Seventeenth Senatorial District:

The Seventeenth Senatorial District shall consist of the municipalities of Augusta, Farmingdale, Hallowell and Manchester, having a combined total population of 28,513.

Eighteenth Senatorial District:

The Eighteenth Senatorial District shall consist of the municipalities of Albion, Benton, Clinton, Waterville, Winslow and the unorganized township of Unity, having a combined total population of 30,292.

Nineteenth Senatorial District:

The Nineteenth Senatorial District shall consist of the municipalities of Chelsea, China, Pittston, Randolph and Windsor, in the County of Kennebec, and all municipalities and unorganized territory in the County of Lincoln, having a combined total population of 28,937.

Twentieth Senatorial District:

The Twentieth Senatorial District shall consist of all municipalities and plantations in the County of Knox, having a combined total population of 29.013.

Twenty-First Senatorial District:

The Twenty-First Senatorial District shall consist of all municipalities, plantations and unorganized territory in the County of Franklin, and of the municipalities of Anson, Bingham, Embden, Jackman, Mercer, Moscow,

Moose River, New Portland, Solon and Starks, the plantations of Bridgton, Caratunk, Dennistown, Highland, Pleasant Ridge, The Forks and West Forks, and all unorganized territory in the County of Somerset, having a combined total population of 31,144.

Twenty-Second Senatorial Districts:

The Twenty-Second Senatorial District shall consist of the municipalities of Athens, Cambridge, Canaan, Cornville, Detroit, Fairfield, Harmony, Hartland, Madison, Norridgewock, Palmyra, Pittsfield, Ripley, St. Albans, Skowhegan and Smithfield, having a combined total population of 31,897.

Twenty-Third Senatorial District:

The Twenty-Third Senatorial District shall consist of all municipalities, plantations and the unorganized territory in the County of Piscataquis, and of the municipalities of Charleston, Corinna, Corinth, Dexter, Exeter, Garland, Lagrange and Newport, in the County of Penobscot, having a combined total population of 27,743.

Twenty-Fourth Senatorial District:

The Twenty-Fourth Senatorial District shall consist of the municipalities of Alton, Bradford, Bradley, Carmel, Clifton, Dixmont, Eddington, Edinburg, Etna, Glenburn, Hampden, Hermon, Holden, Hudson, Kenduskeag, Levant, Newburgh, Old Town, Plymouth, Stetson, the unorganized township of Argyle and the Indian Island Voting District, having a combined total population of 29,071.

Twenty-Fifth Senatorial District:

The Twenty-Fifth Senatorial District shall consist of Ward 7, Precinct 1, and Ward 7, Precinct 2 in the City of Bangor, and the municipalities of Brewer, Orono, Orrington and Veazie, having a combined total population of 28,752.

Twenty-Sixth Senatorial District:

The Twenty-Sixth Senatorial District shall consist of the municipality of Bangor, with the exception of Ward 7, Precinct 1 and Ward 7, Precinct 2, having a combined total population of 27,963.

Twenty-Seventh Senatorial District:

The Twenty-Seventh Senatorial District shall consist of the municipalities of Burlington, Chester, Enfield, East Millinocket, Greenbush, Greenfield, Howland, Lee, Lincoln, Lowell, Mattawamkeag, Maxfield, Medway, Milford, Millinocket, Passadumkeag, Patton, Springfield, Stacyville, Winn and Woodville, the plantations of Carroll, Drew, Grand Falls, Lakeville, Mount Chase, Prentiss, Seboeis and Webster, the unorganized township of Kingman and all other unorganized territory in the County of Penobscot, having a combined total population of 28,149.

Twenty-Eighth Senatorial District:

The Twenty-Eighth Senatorial District shall consist of the municipalities of Bucksport, Orland and Verona in the County of Hancock, and of all municipalities in the County of Waldo, having a combined total population of 28,828.

Twenty-Ninth Senatorial District:

The Twenty-Ninth Senatorial District shall consist of the municipalities of Amherst, Aurora, Bar Harbor, Blue Hill, Brooklin, Brooksville, Cranberry Isles, Castine, Dedham, Deer Isle, Eastbrook, Ellsworth, Franklin, Gouldsboro, Hancock, Lamoine, Mariaville, Mount Desert, Otis, Penobscot, Sedgwick, Sorrento, Southwest Harbor, Stonington, Surry, Swans Island, Sullivan, Tremont, Trenton, Waltham and Winter Harbor, the plantations of Great Pond, Long Island and Osborne, and all unorganized territory within the County of Hancock, having a combined total population of 29,070.

Thirtieth Senatorial District:

The Thirtieth Senatorial District shall consist of all municipalities, plantations and unorganized territory within the County of Washington, having a combined total population of 29,859.

Thirty-First Senatorial District:

The Thirty-First Senatorial District shall consist of the municipalities of Ashland, Amity, Bancroft, Benedicta, Blaine, Bridgewater, Castle Hill, Chapman, Crystal, Dyer Brook, Easton, Haynesville, Hersey, Hodgdon, Houlton, Island Falls, Linneus, Littleton, Ludlow, Mapleton, Mars Hill, Masardis, Merrill, Monticello, New Limerick, Oakfield, Orient, Portage Lake, St. Francis, Sherman, Smyrna, Wade, Westfield and Weston, the plantations of Cary, E. Garfield, Glenwood, Hammond, Macwahoc, Moro, Nashville, Oxbow, Reed and Winterville and all unorganized territory in the County of Aroostook not included within any other Senatorial District, having a combined total population of 31,188.

Thirty-Second Senatorial District:

The Thirty-Second Senatorial District shall consist of the municipalities of Caribou, Fort Fairfield, New Sweden, Perham, Presque Isle, Stockholm, Washburn and Woodland, and the plantation of Westmanland, having a combined total population of 31,377.

Thirty-Third Senatorial District:

The Thirty-Third Senatorial District shall consist of the municipalities of Eagle Lake, Fort Kent, Frenchville, Grand Isle, Limestone, Madawaska, St. Agatha and Van Buren, the plantations of Caswell, Cyr, Hamlin, New Canada, St. John and Wallagrass, the unorganized township of Connor, and the unorganized territory of T. 17, R. 5, T. 17, R. 4, T. 16, R. 6, T. 16, R. 5, and T. 16, R. 4, having a combined total population of 31,513.
