HOUSE AMENDMENT " B " to COMMITTEE AMENDMENT " A " to H.P.  
1450, L. D. 1893, Bill, "AN ACT Reallocating Funds for Professional  
Contractual Employees for the Joint Standing Committees of the  
Legislature."

Amend said amendment by inserting after the 4th paragraph  
the following:

'Sec. 2. R. S., T. 2, § 51, amended. The first 2 sentences  
of section 51 of Title 2 of the Revised Statutes are amended to  
read as follows:

Each member of the Executive Council shall receive the same  
compensation and travel as a Representative to the Legislature,  
for services as a Councilor during any biennium ~~the-session-of-the  
Council-commencing-in-January-and-closing-immediately-after-the  
adjournment-of-the-Legislature.--For-services-at-other-sessions  
of-the-Council,~~ each member thereof shall receive \$20 for each  
session, and actual expenses. For sessions when the Legislature  
is not in session each member of the Council shall receive \$20  
for each session and actual expenses.

Further amend said amendment in the 5th paragraph by  
striking out at the beginning of the first line the following:  
"Sec. 2." and inserting in place thereof the following: 'Sec. 3.'

Further amend said amendment in the 6th paragraph by striking  
out at the beginning of the first line the following: "Sec. 3."  
and inserting in place thereof the following: 'Sec. 4.'

Further amend said amendment in the 7th paragraph by striking out at the beginning of the first line the following: "Sec. 4." and inserting in place thereof the following: 'Sec. 5.'

Further amend said amendment in the 8th paragraph by striking out at the beginning of the first line the following: "Sec. 5." and inserting in place thereof the following: 'Sec. 6.'

Further amend said amendment in the 8th paragraph by striking out in the first line the following: "3 and 4" and inserting in place thereof the following: '3, 4 and 5'

Statement of Fact

This amendment amends Title 2, section 51 to make the compensation of the Executive Council consistent with that of Legislators.
