Further amend said Bill in that part designated "<u>§5013.</u>" of section 11 by inserting after the underlined words "<u>cause by the</u>" in the last line of subsection 1 (next to last line of subsection 1 in L. D.) the underlined words '<u>commissioner with the approval of the</u>'; and by inserting after the underlined words "<u>cause by the</u>" in the next to the last line and in the last line of subsection 2 (same in L. D.) the underlined words '<u>commissioner with the approval of the</u>'; and by inserting after the underlined words "<u>cause by the</u>" in the last line of subsection 3 (same in L. D.) the underlined words '<u>commissioner</u> with the approval of the'; and by inserting after the underlined words "<u>cause by the</u>" in the last line of subsection 4 (next to the last line in L. D.) the underlined words '<u>commissioner</u> with the approval of the'

2. Bureau. "Bureau" means the Bureau of Watercraft Registration and Safety established-in-section-231 within the Department of Natural Resources.

Sec. 13. R. S., T. 38, §201, sub-§3, repealed and replaced. Subsection 3 of section 201 of Title 38 of the Revised Statutes is repealed and the following enacted in place thereof:

3. Bureau heads. "Bureau heads" means the Department of Natural Resources.

Sec. 14. R. S., T. 38, §201, sub-§17, additional. Section 201 of Title 38 of the Revised Statutes is amended by adding a new subsection 17 to read as follows:

17. Director. "Director" means the Director of the Bureau of Watercraft Registration and Safety. The director shall be appointed by the Commissioner of Natural Resources, subject to the Personnel Law. The director shall have authority to do any act within this subchapter previously delegated to either of the bureau heads.

Sec. 15. R. S., T. 38, §203, sub-§3, "B, amended. Paragraph B of subsection 3 of section 203 of Title 38 of the Revised Statutes is amended to read as follows:

<u>B.</u> Each fiscal year any amount in the Watercraft Fund, which in the discretion of the 2-buscau-heads <u>Consissioner of Natural</u> <u>Resources</u> is not needed for the bureau personnel, office and administrative expenses, is to be paid over to the <u>Beracker</u>

Further amond said Bill by inserting after section 14 the Job Part

'Sec. 21. Amondatory clause. Wherever in the Bevised Statefree, Title 32, sections 201 to 247, the words "bureau head" or "bureau heads" appear they shall mean the Deposition to Matural Resource ...

Further amond said Bill by renumbering pections 15 and 16 to be sections 22 and 23.
