SENATE AMENDMENT "B" to S. P. 768, L. D. 2047, Bill, "AN ACT to Appropriate Moneys for the Expenditures of State Government and Other Purposes for the Fiscal Years Ending June 30, 1972 and June 30, 1973."

Amend said Bill by inserting at the end, before the emergency clause, the following:

'SECTION M

Sec. 1. R. S., T. 4, §4, amended. The first sentence of section 4 of Title 4 of the Revised Statutes, as amended, is further amended to read as follows:

The Justices of the Supreme Judicial Court shall each receive an annual salary of ~~\$21,250~~ \$24,000, and the Chief Justice of the Supreme Judicial Court shall receive an annual salary of ~~\$22,750~~ \$24,000.

Sec. 2. R. S., T. 4, §102, amended. The first sentence of section 102 of Title 4 of the Revised Statutes, as amended, is further amended to read as follows:

Each of the Justices of the Superior Court shall receive an annual salary of ~~\$21,000~~ \$23,500.

Sec. 3. Appropriation. There is appropriated from the General Fund to the Supreme Judicial and Superior Courts the sum of \$49,000 for the fiscal year ending June 30, 1973 to carry out the purposes of SECTION M. The breakdown shall be as follows:

Further amend said Bill by striking out all of the emergency clause and inserting in place thereof the following:

'Emergency clause. In view of the emergency cited in the preamble, SECTIONS A, B, C, D, I, K and L of this Act shall become effective upon approval and SECTIONS E, F, G, H, J and M shall become effective July 1, 1972.'
