STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED
SEVENTY-THREE

AN ACT Transferring Duties of Maine School Building Authority to
State Board of Education.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 20, § 51, sub-§ 3, ¶ E, additional. Subsection 3 of section 51 of Title 20 of the Revised Statutes, as enacted by section 4 of chapter 610 of the public laws of 1971, is amended by adding a new paragraph E to read as follows:

E. It shall assume all the duties, powers and obligations of the Maine School Building Authority as set forth in sections 3502 to 3517.

Sec. 2. R. S., T. 20, §§ 3501 and 3504, repealed. Section 3501 and section 3504, as amended, both of Title 20 of the Revised Statutes are repealed.

Sec. 3. R. S., T. 20, § 3506, sub-§§ 2 and 3 repealed. Subsections 2 and 3 of section 3506 of Title 20 of the Revised Statutes are repealed.

Sec. 4. R. S., T. 20, § 3506, sub-§ 4, amended. Subsection 4 of section 3506 of Title 20 of the Revised Statutes is amended to read as follows:

4. Sue and be sued. To sue and be sued in its own name, plead and be impleaded in civil actions relating to school projects as stated in subsection 5; any and all civil actions against the authority board shall be brought only in the county in which the principal office of the authority shall be located Kennebec County;

Sec. 5. Amendatory clause. Wherever in the Revised Statutes the words "Maine School Building Authority" are used they shall mean the "State Board of Education" as the context may require.

Sec. 6. Effective date, transition. This Act shall be effective 90 days after the recess of the Legislature. It shall be operative and the State Board shall assume its duties on January 1, 1974.

STATEMENT OF FACT

The purpose of this Act is to transfer the duties of the Maine School Building Authority to the State Board of Education.
