COMMITTEE AMENDMENT" A " to H.P. 478, L.D. 629, Bill, "AN ACT Revising the Motor Vehicle Dealer Licensing Law."

Amend said Bill in section 1 by striking out in the 11th line of subsection 3 of that part designated "§ 341." the underlined words "motor vehicle salesman" and inserting in place thereof the following: 'representative,'

Further amend said Bill in section 1 by striking out in paragraph E of subsection 1 of that part designated "§ 343." the underlined words "other than the dealer" and inserting in place thereof the following: 'who may be the owner'

Further amend said Bill in section 1 by inserting at the end of the last paragraph of that part designated "§343." the following underlined sentence:

'However, the exemption from the requirement as to repair facilities and mechanic will expire in the case of any holder of used car dealer registration plates on January 1, 1964 should said holder relocate his place of business, discontinue his business or sell his business.'

Further amend said Bill in section 1 by striking out all of subsection 2 of that part designated "§ 345." and inserting in place thereof the following:

'2. Copy of appointment. Every applicant for a license to deal in new vehicles shall submit with his application a certification of franchise from the manufacturer of the new vehicles he desires to sell.'

Further amend said Bill in section 1 by inserting after that part designated "§ 348." the following:

'§ 348-A.Change in status of dealership

1. Any new car dealer that terminates his franchise, or his franchise is terminated, shall immediately surrender his new car dealer plates and certificates to the Secretary of State, and the Secretary of State shall issue, if business is to be continued, the appropriate class of plates.

2. A used car dealer who obtains a new car franchise from a manufacturer or distributor shall immediately surrender his used car plates and certificates and the Secretary of State shall issue the appropriate class of plates.'

Further amend said Bill in section 1 by inserting at the end of paragraph "G" of subsection 1 of that part designated "§ 349." before the last punctuation, /the underlined words, punctuation and figures: 'or violation of Title 17, section 3203'

Further amend said Bill in section 1 by inserting in the 3rd of that part designated "§ 363." line/after the word "license" the following underlined words: 'or only a loaner license'

Further amend said Bill in section 1 by inserting in the 19th line of that part designated "§ 363." after the underlined word "license" the following underlined words: 'or only a loaner license'

Further amend said Bill in section 1 by inserting in the 2nd line of the 2nd paragraph of that part designated "§ 363." after the underlined word "license" the following: 'or only a loaner license'

Further amend said Bill in section 1 by striking out in the next to the last line the underlined word "cents" and inserting in place thereof the following: '¢'
