# STATE OF MAINE

## IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-THREE

#### AN ACT Creating the Eustis Sanctuary, Franklin County.

Be it enacted by the People of the State of Maine, as follows:

**R. S., T. 12, § 2101, amended.** Section 2101 of Title 12 of the Revised Statutes, as amended, is further amended by adding after the 6th paragraph 2 new paragraphs to read as follows:

Eustis Sanctuary: The following described tract or territory situated in Eustis, in the County of Franklin: Land of Justin R. Strunk, Jr., being more particularly bounded and described as follows:

Beginning at a post and stones marking the northwestrly corner of Lot 8, Range 6; thence easterly along the northerly line of Lots 8 and 7 Range 6 to a post at the northeasterly corner of Lot 7 Range 6; thence southerly along the easterly line of Lot 7 Range 5 and 6 to a post and stones marking the southeasterly corner of Lot 7 Range 5; thence westerly along the southerly line of Lot 7 Range 5 to a post marking the southwesterly corner of the East One-Half of Lot 7 Range 5; thence continuing westerly along the southerly line of Lot 7 Range 5, 4.50 chains to a post marking the northwesterly corner of a small camp lot; thence southerly along the westerly line of said small camp lot 4.85 chains to a post on the northerly side of the road leading to the Ridge Road; thence easterly along the northerly side of said road about 5 chains to the division line between the East One-Half and West One-Half of Lot 7 Range 4; thence southerly along said division line to a post marking the southeasterly corner of the West One-Half of Lot 7 Range 4; thence westerly along the southerly line of West One-Half of Lot 7, Range 4 to a post and stones marking the southeasterly corner of Lot 8 Range 4; thence southerly along the easterly line of Lot 8 Range 3 and following a wire fence to a post and stones marking the northeasterly corner of a 25 rod strip said to be owned now or formerly by the Coburn Heirs; thence westerly along the northerly line of said 25 rod strip following an old wire fence in part to a post and stones on the west line of Lot 8 Range 3 marking the northwesterly corner of said 25 rod strip; thence northerly along the westerly line of Lot 8 Range 3 to a post marking the northwesterly corner of said Lot 8 Range 3; thence easterly along the northerly line of Lot 8 Range 3 to a post marking the division line between the East One-Half and West One-Half of Lot 8 Range 4; thence northerly along the said division line between Lot 8 Range 4 and 5 to a post marking the northwesterly corner of East One-Half of Lot 8 Range 5; thence westerly along the southerly line of Lot 8 Range 6 to a post marking the southwesterly corner of Lot 8 Range 6; thence northerly along the westerly line of Lot 8 Range 6 to the point of beginning. Containing 595 acres, more or less. Meaning and intending to describe Lot 7 and 8 Range 6; Lot 7 Range 5; East One-Half of Lot 8 Range 5; Part of West One-Half of Lot 7 Range 4; East One-Half of Lot 8 Range 4; and part of Lot 8 Range 3, but excepting the rights of the public in the road leading from the Ridge Road through West One-Half of Lot 7 Range 4; Lot 7 Range 5; and East One-Half of Lot 8 Range 5, being the same conveyed to the within named Grantor by the three following Warranty Deeds recorded in the Franklin County Registry:

- 1. Deed from Asher E. Sylvester dated March 13, 1963, Book 371, Page 580.
- 2. Deed from Elizabeth E. Sylvester dated December 10, 1960, Book 364, Page 298.
- 3. Deed from Kenneth Packard dated May 24, 1961, Book 364, Page 425.

The commissioner may after notice and public hearing add adjacent property to said game sanctuary upon application of the owners of said adjacent property. If the commissioner determines that the public health and safety is threatened by diseased animals within the Eustis Sanctuary, he may authorize the use of firearms or any other device he deems appropriate to eliminate said animals.
