STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-THREE

AN ACT Transferring Funds from Appropriations to other Departments to the Department of the Attorney General.

Emergency preamble. Whereas, Acts and resolves passed by the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the said 90-day period will not terminate until after the beginning of the next fiscal year; and

Whereas, all Assistant Attorneys General should be on the payroll of the Department of Attorney General in order to have proper control of their activities; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. Appropriation. There is appropriated from the moneys appropriated to the several departments, as shown, to the Department of the Attorney General the amounts indicated for the years July 1, 1973 to June 30, 1974 and July 1, 1974 to June 30, 1975. The breakdown shall be as follows:

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

Sec. 2. Effective date. This Act shall become effective July 1, 1973.

STATEMENT OF FACT

This bill puts Assistant Attorneys General, whose salary and travel are paid for by other departments, on the payroll of the Department of the Attorney General. This will give proper control of the activities of the affected personnel.
