**AN ACT to Make the Industrial Accident Commission Full Time and to
Establish the Salaries of its Members.**

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. R. S., T. 2, § 6, sub-§ 3, amended. Subsection 3 of section 6 of Title 2 of the Revised Statutes, as enacted by chapter 542 of the public laws of 1967 and as amended by section 1 of chapter 531 of the public laws of 1971, is further amended by adding at the end the following:

Chairman of the Industrial Accident Commission.

Sec. 2. R. S., T. 2, § 6, sub-§ 4, amended. Subsection 4 of section 6 of Title 2 of the Revised Statutes, as enacted by chapter 542 of the public laws of 1967 and as amended, is further amended by adding at the end the following:

Industrial Accident Commission members, other than the Chairman.

Sec. 3. R. S., T. 2, § 6, sub-§ 5, amended. Subsection 5 of section 6 of Title 2 of the Revised Statutes, as enacted by chapter 542 of the public laws of 1967 and as amended, is further amended by striking out all of the 5th line as follows:

~~**Chairman of the Industrial Accident Commission;**~~

Sec. 4. R. S., T. 2, § 6, sub-§ 6, amended. Subsection 6 of section 6 of Title 2 of the Revised Statutes, as enacted by chapter 542 of the public laws of 1967 and as amended, is further amended by striking out all of the 6th line as follows:

~~Industrial Accident Commission members, other than the Chairman;~~

Sec. 5. R. S., T. 39, § 91, amended. The first sentence of section 91 of Title 39 of the Revised Statutes, as amended by section 1 of chapter 508 of the public laws of 1965, is further amended to read as follows:

The Industrial Accident Commission, as heretofore established, shall consist of 6 members, 4 of whom shall be men learned in the law and members in good standing of the bar of this State **and who shall serve in full-time capacity.**

Sec. 6. Appropriation. There is appropriated from the General Fund to the Industrial Accident Commission the sum of \$31,500 to carry out the purposes of this Act. The breakdown shall be as follows:
