Amend said Bill in section 2 by striking out all of the amending clause and inserting in place thereof the following:

'Sec. 2. R. S., T. 13-A, §1401, sub-§§ 14 and 15, amended.

Subsections 14 and 15 of section 1401 of Title 13-A of the

Revised Statutes, as enacted by section 1 of chapter 439 of

the public laws of 1971, are amended to read as follows:'

Further amend said Bill in section 2 by striking out all of the last paragraph (same in L. D.)

Further amend said Bill by inserting after section 2 the following:

- 'Sec. 3. R. S., T. 13-A, § 1401, sub-§ 30, repealed and replaced. Subsection 30 of section 1401 of Title 13-A of the Revised Statutes, as enacted by section 1 of chapter 439 of the public laws of 1971, is repealed and the following enacted in place thereof:
- 30. Annual report of a domestic or foreign corporation, as provided by section 1301, \$25 if the authorized capital does not exceed \$1,000,000 or 10,000 shares without par value; \$50 if the authorized capital does exceed \$1,000,000 or 10,000 shares without par value;

Further amend said Bill by renumbering section 3 to be section 4.
