COMMITTEE AMENDMENT "A " to S. P. 488, L. D. 1554, Bill,
"AN ACT Relating to Mobile Home Parks."

Amend said Bill in that part designated "§ 4064." by inserting at the end (same in L. D.) the following underlined sentence: 'No mobile home park owner or operator shall require as a condition of tenancy or continued tenancy that a mobile home owner designate the park owner or operator or any other individual or agent to act as agent for the mobile home owner in the sale of the home owner's mobile home.'

Further amend said Bill in that part designated "§ 4065." in the 3rd line (same in L. D.) by inserting after the underlined word "terminated" the underlined word 'solely'

Further amend said Bill in that part designated "§ 4066." by striking out in the 4th and 5th lines (4th line in L. D. 2 times) the underlined word "natural" and inserting in place thereof the underlined word 'bottled'

Further amend said Bill by inserting at the end before the Statement of Fact the following:

'§ 4067. Violations

A violation of this chapter shall constitute a violation of Title 5, chapter 10, Unfair Trade Practices Act.'

Statement of Fact

The purpose of this amendment is to strengthen and clarify the protection offered by the measure.
