HOUSE AMENDMENT "A" to H. P. 1484, L. D. 1911, Bill,
"AN ACT Relating to Consolidating Reports of State Departments
and Agencies."

Amend said Bill by striking out all of the first paragraph
after the enacting clause and inserting in place thereof the
following:

'Sec. 1. R. S., T. 5, §§43 - 46, additional. Title 5 of
the Revised Statutes is amended by adding 4 new sections to read
as follows:'

Further amend said Bill in that part designated "§43."
of section 1 by striking out in the 3rd line (2nd line in L. D.)
the underlined word "October" and inserting in place thereof
the underlined word 'September'

Further amend said Bill in that part designated "§43."
of section 1 by striking out in the 9th line (8th line in L. D.)
the following "1st" and inserting in place thereof '31st'

Further amend said Bill in that part designated "§44." by
striking out all of subsection 10 and inserting in place thereof
the following:

'10. A description of each program shall be provided
and shall include a summary of major expenditures, goals and objectives
and future plans.'

Further amend said Bill by inserting after that part designated "§44." of section 1 the following:

'§45. Discontinuation of duplicate reports

Notwithstanding any other provisions of law, the Governor may discontinue the publication of any other annual or biannual report which duplicates the report material provided for in section 43. He may order the publication of an expanded departmental report, in standard format, in a limited quantity for record purposes.'

Further amend said Bill by renumbering that part designated "§45." of section 1 to be '§46.'

Further amend said Bill by striking out all of section 2 and inserting in place thereof the following:

'Sec. 2. Appropriation. There is appropriated to the Department of Finance and Administration from the General Fund the sum of \$13,500 to carry out the purposes of this Act. The breakdown shall be as follows:
