## STATE OF MAINE HOUSE OF REPRESENTATIVES 106TH LEGISLATURE

HOUSE AMENDMENT "D" to S. P. 638, L. D. 1973, Bill, "AN ACT to Improve Lobster Fisheries."

Amend said Bill in section 1 by striking out all of that part designated "4-A." and inserting in place thereof the following:

'4-A. Vessel designation. An applicant for a lobster and crab fishing license shall designate on his application the registration number of the motorboat from which he shall fish as issued by the Bureau of Watercraft Registration and Safety or documentation number as issued by the United States Government, notwithstanding that the owner of a currently licensed lobster and crab fishing boat may take a helper without having him licensed. The owner of a boat may haul only traps licensed to that boat. The commissioner shall make a regulation which will allow a boat to haul traps not licensed to it when circumstances prohibit the appropriately licensed boat from hauling its traps. The commissioner shall not issue a lobster and crab fishing license to any applicant, if such applicant has designated in his application the number of a vessel which has already been entered on another license.'

Further amend said Bill by inserting after section 4 the following:

'Sec. 5. R. S., T. 12, §4404, sub-§7, repealed. Subsection 7 of section 4404 of Title 12 of the Revised Statutes is repealed.'

Further amend said Bill in section 5 by inserting at the end the following underlined sentence: 'After December 31, 1973, only replacement licenses will be issued until the number of licenses is reduced to 8,000.'

Further amend said Bill by renumbering section 5 to be section 6.

Further amend said Bill by striking out all of sections 6 and 7.

Further amend said Bill by inserting at the end, before the

'Sec. 7. R. S., T. 12, §4461, amended. Section 4461 of Title

12 of the Revised Statutes is amended by adding at the end a new

paragraph to read as follows:

The commissioner may promulgate a regulation for the purposes of implementating this section subject to the approval of the Sea and Shore Fisheries Advisory Council.'

## Statement of Fact

The purpose of this amendment is to license a boat in order to make a trap limit functional. The amendment also provides for a license ceiling and repeals the section which prohibits a stern man from fishing on a licensed lobster and crab fishing boat.
