'All Other 483,372'

Further amend said Bill in section 19 under the caption "MENTAL HEALTH AND CORRECTIONS, DEPARTMENT OF" in that part relating to Men's Correctional Center by striking out all of the line relating to All Other and inserting in place thereof the following:

'All Other 226,439'

Further amend said Bill in section 19 under the caption "MENTAL HEALTH AND CORRECTIONS, DEPARTMENT OF" in that part relating to Boys' Training Center by striking out all of the line relating to All Other and inserting in place thereof the following:

'All Other 371,100'

Further amend said Bill in section 19 under the caption "MENTAL HEALTH AND CORRECTIONS, DEPARTMENT OF" in that part relating to Stevens School by striking out all of the line relating to All Other and inserting in place thereof the following:

All Other 155,066'

'TOTAL GENERAL FUND APPROPRIATION \$178,919,893'
