Further amend said Bill in section 20 under the caption "MENTAL HEALTH AND CORRECTIONS, DEPARTMENT OF" in that part relating to Men's Correctional Center by striking out all of the line relating to All Other and inserting in place thereof the following:

'All Other 222,340'

Further amend said Bill in section 20 under the caption "MENTAL HEALTH AND CORRECTIONS, DEPARTMENT OF" in that part relating to Boys' Training Center by striking out all of the line relating to All Other and inserting in place thereof the following:
