## STATE OF MAINE HOUSE OF REPRESENTATIVES 106TH LEGISLATURE FIRST SPECIAL SESSION

HOUSE AMENDMENT "A" to HOUSE AMENDMENT "B" to H. P. 2047, L. D. 2580, Bill, "AN ACT Providing for a Workmen's Compensation Insurance Fund."

Amend said Amendment by inserting before the first paragraph the following:

'Amend said Bill in section 1 by striking out in the 12th, 13th, 14th and 15th lines of that part designated "§201." (10th, 11th, 12th and 13th lines in L. D.) the underlined words and punctuation ", but it is the intention of the Legislature that, with the exception of self-insurers, the said fund shall be the sole provider of insurance for liabilities for injuries compensable under this Act"

Further amend said Amendment by inserting at the beginning of the first line the following: 'Further amend' and by striking out the word "Amend"

Further amend said Amendment by inserting at the end before the Statement of Fact the following:

'Further amend said Bill in section 1 by inserting after the underlined word "liability" in the 5th line of that part designated "§234." (same in L. D.) the underlined word 'insurance'

Further amend said Bill in section 1 by striking out in the 2nd line of that part designated "§242." (same in L. D.) the underlined word "The" and inserting in place thereof the following:

'In the case of employers securing insurance from this fund the'

Further amend said Bill in section 2 by striking out in the 7th line (6th and 7th in ! ) the underlined words "as limited herein"

Further amend said Bill by striking out all of section 3 and inserting implace thereof the following:

- 'Sec. 3. R. S., T. 39, §23, sub-§1-A, additional. Section 23 of Title 39 of the Revised Statutes, as amended, is further amended by adding a new subsection 1-A to read as follows:
- 1-A. By insuring and keeping insured the payment of such compensation and other benefits under an insurance policy with the Workmen's Compensation Insurance Fund.'

Further amend said Bill by striking out all of section 4.

Further amend said Bill by renumbering section 5 to be section 4.
