

HOUSE AMENDMENT "H" to COMMITTEE AMENDMENT "A" to
H.P. 464, L.D. 566, Bill, "AN ACT to Increase Certain Hunting
and Fishing License Fees."

Amend said Amendment in section 3 in the 13th line
by striking out the underlined figure "\$12.50" and inserting
in place thereof the underlined figure '\$11' and in the 15th
line by striking out the underlined figure "\$5.50" and
inserting in place thereof the underlined figure '\$4'

Further amend said Amendment in section 8-A in
paragraph A by striking out the following: "~~\$1.50~~ \$2.50"
and inserting in place thereof '\$1.50'; in paragraph B
by striking out the following: "~~\$6.50~~ \$8.50" and inserting
in place thereof '\$6.50'; in paragraph C by striking out
the underlined figure "\$15.50" and inserting in place thereof
the underlined figure '\$16.50'; in paragraph D by striking
out the following "~~\$10.50~~ \$13.50" and inserting in place
thereof the  figure '\$10.50'; in paragraph E by
striking out the following: "\$28.50" and inserting in place
thereof the underlined figure '\$35.50' and in paragraph
F by striking out the underlined figure "\$58.50" and inserting
in place thereof the underlined figure '\$65.50'

Further amend said Amendment in section 9 in subsection 3
in paragraph A by striking out the underlined figure "\$3.50"
and inserting in place thereof the underlined figure '\$6.50'

Further amend said / in section 9 in subsection 3
by striking out all of paragraph B and inserting in place
thereof the following:

'B. Resident fishing \$6.50
±6 18 years of age or older.'

Further amend said / in section 9 in subsection 3
by striking out all of paragraph C and inserting in place
thereof the following:

C. Resident-or-nonresident
Nonresident 3-day fishing \$6.50 \$12.50

~~Any-resident-of-the-State-who
procures-a-3-day-license-may
exchange-the-same-for-an-annual
resident-fishing-license-in-the
town-in-which-he-resides-upon
the-payment-of-50¢-to-the-clerk
or-issuing-agent.~~

C-1. Resident 3-day fishing \$6.50

Any resident of the State who
procures a 3-day license may
exchange the same for an annual
resident fishing license in the
town in which he resides upon
the payment of 50¢ to the clerk
or issuing agent.

Further amend said Amendment in section 17 in the
9th line by striking out the underlined figure "\$58.50"
and inserting in place thereof the underlined figure
'\$65.50'

Statement of Fact

It is the purpose of this amendment to increase revenues
derived from fish and game licenses and snowmobile registrations
to maintain existing levels of services. The adjustment is
estimated to generate \$1,000,000 in additional revenue
necessary for departmental operation.
