STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-FIVE

AN ACT to Increase the Annual Salaries of Certain County Officials by 20%.

Be it enacted by the People of the State of Maine, as follows:

30 MRSA § 2, $\|\|$ 2 to 17, as amended, are repealed and the following enacted in place thereof:

STATEMENT OF FACT

This Act will increase the salaries of certain county officials by 20%. An increase in salaries is essential, due to ever-rising costs and in order to attract qualified candidates for various county positions. The present pay scale for county officials is tremendously low in comparison to the duties which they perform and is nowhere near the present rate of pay of the state officials.
