STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-FIVE

AN ACT Relating to Salaries of Jury Commissioners and County Officers in Lincoln County.

Emergency preamble. Whereas, Acts and resolves of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the following legislation is vitally necessary to adjust salaries of jury commissioners and county officers in Lincoln County; and

Whereas, such adjustments are needed at the earliest possible moment to meet the ever-increasing costs of living; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 14 MRSA § 1252, first ¶, that part which relates to the jury commissioners of Lincoln County, as last amended by PL 1973, c. 724, § 1, is further amended to read:

Lincoln, \$150 first commissioner, \$300; second commissioner, \$300;

Sec. 2. 30 MRSA § 2, 9th ¶, that part which relates to Lincoln County, as last amended by PL 1973, c. 724, § 3, is further amended to read:

Lincoln County: County commissioners, \$1,670 \$1,790 fiscal year 1975, and \$1,880 thereafter; chairman, \$2,226 \$2,448 fiscal year 1975, and \$2,503 thereafter; clerk of courts, \$7,011 \$8,000 fiscal year 1975, and \$8,245 thereafter; county treasurer, \$2,337 \$2,617 fiscal year 1975, and \$2,748 thereafter; sheriff, \$7,791 \$10,000; register of deeds, \$7,012 \$8,500 fiscal year 1975, and \$8,925 thereafter; judge of probate, \$6,678 \$7,000; register of probate, \$6,789 \$7,500 fiscal year 1975, and \$7,875 thereafter;

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

STATEMENT OF FACT

The intent of this Act is reflected in the emergency preamble.
