AN ACT Establishing a Limited Open Season on Moose.

Be it enacted by the People of the State of Maine, as follows:

12 MRSA § 2355-E is enacted to read:

§ 2355-E. Moose; open season

There will be a limited open season on moose from September 22 to September 27, 1975 and from September 20 to September 25, 1976. Moose hunting shall be permitted in Wildlife Management Units 1 and 2, except in all of Baxter State Park and except in T3, R11 WELS; T4, R11 WELS; T5, R11 WELS; T6, R11 WELS; T7, R10 WELS; T7, R9; T6, R8; T5, R8; T4, R8; T3, R8; T2, R9 and T2, R10.

The Commissioner of Inland Fisheries and Game is authorized to issue not more than 1,000 moose hunting permits each season. Any resident hunting license holder may, upon payment of a non-refundable fee of \$3, apply for a moose permit. One thousand hunters will be randomly selected from among the applicants. Each hunter selected may then choose one person to hunt with him or her. Upon payment of one \$50 license fee, the 2 hunters will receive one moose permit allowing either of them to take one moose. One moose of either sex may be taken by each pair of hunters. All moose must be tagged with the hunters' license tag immediately and all moose harvested must be presented at an established moose registration station. Section 2355, subsections 1 to 7, which apply to the registration, possession, giving away and transportation of deer shall likewise apply to all moose taken, except that no fee will be charged for registering moose.

In Wildlife Management Units 1 and 2, during the moose season, it shall be unlawful for anyone not licensed to take moose to hunt with a rifle or with rifled slugs, any wild birds or wild game. Possession of a rifle in the fields and forests or on the waters or in a motor vehicle being operated on an unpaved highway located in an unorganized township shall be prima facie evidence of such hunting, unless such firearm is carried, securely wrapped in a complete cover, fastened in a case or carried in at least 2 separate pieces in such a manner that it cannot be fired unless the separate pieces are joined together again. For the purposes of this section a clip, magazine or cylinder of a firearm shall not be considered a piece of such a rifle. No .22 caliber rim fire firearms may be used to hunt moose.

The commissioner is authorized to make any other rules and regulations he may deem necessary for the administration of this section.

Any moose legally taken under this section shall not be in violation of section 2467.

No person who is licensed to hunt moose during the 1975 moose season shall be eligible to apply for a moose hunting license in 1976.

Whoever violates any of the provisions of this section or rules and regulations promulgated thereunder shall be punished, upon conviction, by a fine of not less than \$500 nor more than \$1,000, or by imprisonment for not more than 6 months, or by both. Also, upon conviction the commissioner may suspend the hunting license for a period of 3 years.

In addition, should future moose seasons be held after 1976, anyone convicted of any violation of this section shall be ineligible for a moose license for 5 years.

FISCAL NOTE

The passage of this bill would bring an increased revenue to the State of \$170,000 for the fiscal year 1975-76.

STATEMENT OF FACT

The intent of this bill is to establish an open season on moose on a limited basis.
