

## STATE OF MAINE HOUSE OF REPRESENTATIVES 107TH LEGISLATURE

HOUSE AMENDMENT "C" to H.P. 1118, L.D. 1415, Bill, "AN ACT Relating to Commercial Fishing and the Increase of Certain License Fees Issued by the Department of Marine Resources."

Amend said Bill in section 20 by inserting at the end the following new sentence:

'The fee for a lobster and crab fishing license issued to any person who qualifies for that license and who is under the age of 18 years at the time of issuance of that license shall be \$10.'

Further amend said Bill by striking out all of section 21 and inserting in place thereof the following:

'Sec. 21. Appropriation. There is appropriated from the General Fund the sum of \$366,200 to carry out the purposes of this Act. The breakdown shall be as follows:

This amendment reduces the lobster and crab fishing license fee to \$10 for persons under the age of 18 and reduces the personal services appropriation under Administration, Marketing, Research and Extension to compensate for the reduced income.
