HOUSE AMENDMENT " D " to H.P. 1118, L. D. 1415, Bill,  
"AN ACT Relating to Commercial Fishing and the Increase of  
Certain License Fees Issued by the Department of Marine  
Resources."

Amend said Bill in section 8 in paragraph A in the first  
line by striking out the underlined figure "\$25" and inserting  
in place thereof the underlined figure '\$15'

Further amend said Bill in section 9 in paragraph A  
in the 2nd line (first line in L.D.) by striking out the  
underlined figure "\$10" and inserting in place thereof the  
underlined figure '\$5'

Further amend said Bill in section 12 in paragraph A in  
the first line (same in L.D.) by striking out the underlined  
figure "\$10" and inserting in place thereof the underlined  
figure '\$5'

Further amend said Bill in section 15 in paragraph A in  
the first line (same in L.D.) by striking out the underlined  
figure "\$10" and inserting in place thereof the underlined  
figure '\$5'

Further amend said Bill in section 20 in subsection 5  
in the 2nd line (1st line in L.D.) by striking out the under-  
lined figure "\$25" and inserting in place thereof the under-  
lined figure '\$15'

Further amend said Bill by striking out all of section 21 and inserting in place thereof the following:

'Sec. 21. Appropriation. There is appropriated from the General Fund the sum of \$228,550 to carry out the purposes of this Act. The breakdown shall be as follows:
