HOUSE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to S.P. 443,
L.D. 1503, Bill, "AN ACT to Amend the Air Pollution Standards
to Expand the Definition of Treatment and to Affirm that
Meeting State Air Quality and Emission Standards will no
Projects Meeting/Significantly Deteriorate Existing Air
Quality."

Amend said amendment by inserting at the beginning of
the 2nd paragraph the following: 'Sec. 1.'

Further amend said Amendment by inserting after the 3rd
paragraph the following:

'Sec. 2. 38 MRSA §590, as last amended by PL 1971, c. 618,
§2, is further amended by adding after the 2nd paragraph the
following new paragraph to read:

If the requirement of best practicable treatment is to be
met in whole or in part by the use of designated fuel types,
the board shall require the equivalent reduction or control of
emissions in the event that the applicant is unable to obtain
such fuel types.'

Statement of Fact

This amendment clarifies the provisions relating to best
practical treatment when that treatment relates to use of certain
fuel types.
