## STATE OF MAINE SENATE 107TH LEGISLATURE

SENATE AMENDMENT "B" to S.P. 469, L.D. 1603, Bill,
"AN ACT to Prohibit the Arbitrary Imposition of Certain Fuel
'harges by Electric Power Utilities."

Amend said Bill by striking out all of that part designated "\$131." of section 1.

Further amend said Bill by striking out all of the first underlined sentence of subsection 1 of that part designated "§132." of section 1 and inserting in place thereof the following:

'The cost of any and all fuel used by an electric utility in generating or supplying electricity to a customer shall be included in the itemized fuel charge and shall be billed at a single uniform rate per kilowatt-hour used by a customer.'

Further amend said Bill by striking out all of the last anderlined sentence of subsection 1 of that part designated "§132." of section 1.

Further amend said Bill by striking out in the next to the last line of subsection 3 of that part designated "§132." (last line in L.D.) the underlined words "increases in"

Further amend said Bill in section 3 by striking out in the 2nd line (same in L.D.) the words "charge" and inserting in place thereof the words 'adjustment clause'

Further amend said Bill by renumbering that part designated "§132." of section 1 to be '§131.'
