SENATE AMENDMENT " B " to H.P. 1631, L.D. 1906, Bill, "AN ACT Authorizing the Licensing of Indoor Tennis Clubs, Indoor Skating Clubs and Golf Course Clubs for the Sale of Alcoholic Beverages without Requiring the Sale of Food."

Amend said Bill by striking out all of the Title and inserting in place thereof the following: 'AN ACT Authorizing the Licensing of Indoor Tennis Clubs, Indoor Ice Skating Clubs and Golf Course Clubs for the Sale of Alcoholic Beverages.'

Further amend said Bill in section 1 in that part designated "<u>10-B.</u>" by inserting in the first line 2 times before the underlined words "<u>skating club</u>" the underlined word '<u>ice</u>'

Further amend said Bill in section 1 in that part designated "<u>10-B.</u>" by inserting in the 2nd line before the underlined word "skating" the underlined word 'ice'

Further amend said Bill in section 2 by inserting in the first line after the amending clause before the underlined word "skating" the underlined word 'ice'

Further amend said Bill in section 2 by inserting in the 3rd line after the amending clause before the underlined word "skating" the underlined word 'ice'

Further amend said Bill in section 4 in that part designated "<u>\$807.</u>" by inserting in the first line before the underlined words "<u>skating clubs</u>" the underlined word '<u>ice'</u>

Further amend said Bill in section 4 in that part designated "<u>§807.</u>" by inserting at the beginning of the 3rd line (2nd line of L.D.) the following: '<u>1. Issue of licenses.</u>'

Further amend said Bill in section 4 in that part designated "<u>\$807.</u>" by inserting in the 5th line (4th line of L.D.) before the underlined words "<u>skating clubs</u>" the underlined word 'ice'

Further amend said Bill in section 4 by inserting at the end the following:

'2. Food availability. Food shall be for sale to the public at all times that liquor is for sale.

3. Separate area for sale of food and liquor. A separate area shall be set aside for the sale of food and liquor in these recreational clubs in accordance with the rules of the Bureau of Alcoholic Beverages.'

Further amend said Bill in section 5 by inserting in the 3rd line (2nd line of L.D.) before the words "skating clubs" the word 'ice'

Further amend said Bill by inserting at the end the following:

'Sec. 6. Application limited. This Act shall remain in effect only until January 1, 1977 during which time the Bureau of Alcoholic Beverages shall evaluate the effectiveness of this law and make a written report to the 108th Legislature.' 6 . E.

## Statement of Fact

The purpose of this amendment is to mandate a food requirement before liquor can be served in a recreational facility and to ensure that the term "skating club" refers to "ice skating club." This amendment also puts a section on the bill concerning an application limit.
