STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-SIX

AN ACT Appropriating Funds to the Maine Correctional Advisory Commission.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, this proposed legislation appropriates funds to the Maine Correctional Advisory Commission for fiscal year 1976-77, which begins July 1, 1976; and

Whereas, it is possible that the fiscal year 1976-77 will begin before the expiration of 90 days after the adjournment of this special legislative session; and

Whereas, it is vital that funding for the 2nd year of the biennium be available to the commission beginning July 1st; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Maine Correctional Advisory Commission; appropriation. There is appropriated from the General Fund to the Maine Correctional Advisory Commission for the fiscal year 1976-77 the sum of \$5,000 to be used to carry out the purposes of that commission.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

STATEMENT OF FACT

The purpose of this bill is to appropriate \$5,000 for fiscal year 1976-77 to the Maine Correctional Advisory Commission.
