COMMITTEE AMENDMENT "A" to H.P. 2053, L.D. 2230, RESOLVE, for Laying of Additional County Taxes for the Year Nineteen Hundred and Seventy-six and to Authorize Certain Reallocations to Conform with Line Budget Statutes.

Amend said Resolve by striking out all of the title and inserting in place thereof the following:

'RESOLVE, for Revising the Amounts of County Taxes for the Year Nineteen Hundred and Seventy-six.'

Further amend said Resolve by striking out everything after the title ~~←~~ and inserting in place thereof the following:

'Resolves, 1975, c. 15, amended. Resolved: That Resolve , 1975, c. 15, that portion pertaining to the sums apportioned to the 1976 county budgets is repealed and the following enacted in place thereof:

RESOLVED: that Resolves, 1975, c. 15, is amended by adding after the last paragraph before the emergency clause, a new paragraph to read:

The figures in the Revised Budget 1976 are based upon revised budgets approved by the Legislature and filed in the office of the Secretary of State. The Secretary of State, upon this resolve becoming effective, shall forward to the chairman of the commissioners each county of/whose budget is revised from the budget approved by Resolves, 1975, c. 15, a certified copy of the county's revised budget for 1976 in summary form and shall provide specific total amounts, where these are altered, for personal services, contractual services, commodities, debt service, capital expenditures and contingent.'

This amendment revises the 1976 county budgets.
