HOUSE AMENDMENT "A" to SENATE AMENDMENT "B" to H.P. 2090,  
L.D. 2249, Bill, "AN ACT to Improve Solid Waste Management."

Amend said Amendment by inserting after the 17th paragraph  
the following:

'Further amend said Bill in section 16 in that part designated  
"§1862." by striking out in subsection 1 the following underlined  
punctuation and words "wine, liquor or alcohol as defined by Title  
28, section 2, subsections 1, 13 and 25,"

Further amend said Bill in section 16 in that part designated  
"§1862." by striking out in subsection 12 the following underlined  
punctuation and words ", provided that consumption can reasonably  
be expected to take place within 100 yards of the place of actual  
sale and the dealer provides suitable means for the disposal  
of beverage containers once consumed"

Further amend said Amendment by inserting at the end of  
the 22nd paragraph the following:

'; and by striking out in the 3rd line the underlined word  
"refundable"

Further amend said Amendment by striking out in the  
last line of 24th paragraph the underlined words "sold by the dealer"

Further amend said Amendment by inserting after the  
24th paragraph the following:

'Further amend said Bill in section 16 in that part designated  
"§1867." by inserting at the end of subsection 1 the following  
underlined sentence:

This section shall not require an operator of a vending machine to maintain a person to accept returned beverage containers on the premises where the vending machine is located.

Further amend said Bill in section 16 in that part designated "§1867." by striking out after the underlined word "handling" in subsection 5 the underlined word "refundable"

Further amend said Amendment by inserting after the semicolon in the 4th line of the 26th paragraph the following: 'and by striking out in the last line of subsection 1 the underlined figure "1867" and inserting in place thereof the underlined figure '1866';'

Further amend said Amendment by inserting after the 26th paragraph the following:

'Further amend said Bill in section 16 in that part designated "§1870." by striking out in the 2nd line the underlined words and figures "After January 1, 1977, no" and inserting in place thereof the underlined word 'No'
