HOUSE AMENDMENT " j)" to COMMITTEE AMENDMENT "A" to H.P. 2143, L.D. 2286, Bill, "AN ACT to Reorganize or Repeal Certain Activities and Agencies in Maine State Government."

Amendment Amend said / by inserting after the 2nd paragraph of section 9 the following:

'The commissioner shall have the power to appoint associate\_ commissioners, and bureau and institutional heads as shall be\_ necessary for the proper performance of the duties of the department.

The commissioner shall appoint an associate commissioner for program and an associate commissioner for administration to assist in carrying out the responsibilities of the department. The associate commissioner for program shall be a person with training and experience in the planning and administration of human services. <u>the associate commissioner for administration shall be a person</u> with training and experience in general management.'

Further amend said Amendment by striking out all of the 12th, 13th and 15th paragraphs and inserting in place thereof the following:

HOUSE AMENDMENT" "" to COMMITTEE AMENDMENT" A" HP 2143, LD. 2286 -2-

'The bureau directors and the heads of the several institutions within the department shall report directly to the commissioner.

In the event of a vacancy in the office of the commissioner or during his absence or disability, the associate commissioner for program shall perform such duties and have the same powers as provided by law for the commissioner. In the event of vacancy in both the office of commissioner and the office of the associate commissioner for program, or during the absence or disability of both officials, the associate commissioner for administration shall perform such duties and have the same powers as provided by law for the commissioner.

Wherever in this Title powers and duties are given to the department, these may be and shall be assumed and carried out by such of the associate commissioners, bureau directors or institutional heads as the commissioner may designate from time to time, and these powers and duties so delegated may in turn be delegated by the aforesaid officers with the approval of the commissioner.' Further amend said Amendment in the 16th paragraph in that part designated "\$526." by striking out in the 2nd line the underlined words "and consent"; in the 3rd line by inserting after the underlined word "salary" the underlined punctuation and words ', subject to the approval of the Governor and Council,'; and by striking out in the 9th to 11th lines the underlined punctuation and words ', provided that the commissioner shall obtain the advice of the advisory commission prior to removing the Director of Corrections from office'

Further amend said Amendment in the 18th paragraph in that part designated "\$2002." in the 2nd line by striking out the underlined words "and consent" and by inserting in the 3rd line after the underlined word "salary" the underlined punctuation and words ', subject to the approval of the Governor and Council,'; and by striking out in the 9th to 11th lines the underlined punctuation and words ', provided that the commissioner shall obtain the advice of the committee prior to removing the Director of Mental Health from office'

Further amend said Amendment in the 20th paragraph in that part designated "<u>§2062.</u>"by striking out in the 2nd line the underlined words "<u>and consent</u>"; by inserting in the 4th line after the underlined word "<u>salary</u>" the underlined punctuation and words ', <u>subject to the approval of the Governor</u> <u>and Council</u>,'; and by striking out in the 10th to 12th lines the underlined punctuation and words ', <u>provided that the</u> <u>commissioner shall obtain the advice of the committee prior</u> to removing the Director of Mental Retardation from office'

Further amend said Amendment by striking out all of the 3rd paragraph before the Statement of Fact.
