RESOLVE, Authorizing the Commissioner of Conservation to Convey Land to Somerset County Formerly Known as the Women's Correctional Center at Skowhegan.

Commissioner of Conservation; authorized to convey land. Resolved: That the Commissioner of Conservation is authorized and directed to convey to the County of Somerset by quit claim deed, for \$1 and other good and valuable consideration, all right, title and interest of the State in and to a certain parcel of land situated in the County of Somerset and State of Maine and comprising a part of the property of the State formerly occupied by the Women's Correctional Center, consisting of 23.8 acres more or less, bounded and described as follows:

A parcel of land, with buildings, situated in the Town of Skowhegan, Somerset County, containing 23.8 acres more or less, to wit:

Beginning at a point on the west side of Norridgewock Avenue where Norridgewock Avenue is intersected by the northerly boundary line of the former Women's Correctional Center at Skowhegan, thence in a southwesterly direction along the west side of Norridgewock Avenue for approximately 917.5 feet, thence in a northwesterly direction approximately 925 feet, thence in a northeasterly direction approximately 1,000 feet to the northerly boundary of the former Women's Correctional Center at Skowhegan, thence in a southeasterly direction along said boundary line approximately 1,237.5 feet to the point of beginning. Such parcel to also include the adjoining sewage treatment plant south of Norridgewock Avenue.

STATEMENT OF FACT

It is the purpose of this resolve to convey the state's interest in land and buildings consisting of #10 and #11 on the attached map and the adjacent sewage treatment plant, which were formerly used by the State as the Women's Correctional Center, to the County of Somerset.
