HOUSE AMENDMENT " G " to H.P. 371, L.D. 435, Bill, "AN ACT to Revise the Salaries of County Officers."

Amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph A, by striking out all of the first line of subparagraph (2) and inserting in its place the following:

' (2) Franklin, Hancock, Sagadahoc and Waldo Counties:'

Further amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph A, by adding at the end the following:

' (4) Knox County:

<u>(a) County commissioners, chairman,</u>	<u>\$2,112;</u>
<u>member,</u>	<u>2,112;</u>
<u>(b) Sheriff,</u>	<u>12,000;</u>
<u>(c) Judge of probate,</u>	<u>6,431; and</u>
<u>(d) Register of probate,</u>	<u>6,450;</u>

' (5) Lincoln County:

<u>(a) County commissioners, chairman,</u>	<u>\$2,549;</u>
<u>member,</u>	<u>1,912;</u>
<u>(b) Sheriff,</u>	<u>12,000;</u>
<u>(c) Judge of probate,</u>	<u>7,879; and</u>
<u>(d) Register of probate,</u>	<u>8,028.'</u>

Further amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph C, by striking out all of subparagraph (2) and inserting in its place the following:

' (2) Northern and Southern Districts of Aroostook County and Franklin, Hancock, Sagadahoc and Waldo Counties, \$8,300;'

Further amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph C, by adding at the end the following:

' (5) Knox County,	<u>\$7,279; and</u>
(6) Lincoln County,	<u>9,500.'</u>

Statement of Fact

The purpose of this amendment is to adjust the salary levels for county officials in Knox and Lincoln Counties in accordance with budgeted funds, except for the Knox County sheriff.
