HOUSE AMENDMENT " I " to H.P. 371, L.D. 435, Bill, "AN  
ACT to Revise the Salaries of County Officers."

Amend the Bill in section 3 in that part designated "§2."  
in subsection 1, paragraph A by striking out the first 2 lines  
of subparagraph (1), (same in L.D.) and inserting in their  
place the following:

' (1) Androscoggin, Aroostook, Cumberland, Kennebec and  
York Counties:'

Further amend the Bill in section 3 in that part designated  
"§2." in subsection 1, paragraph A by adding at the end the  
following:

' (4) Penobscot County:

<u>(a) County commissioners, chairman,</u>	<u>\$4,246;</u>
<u>member,</u>	<u>3,948;</u>
<u>(b) Sheriff,</u>	<u>8,136;</u>
<u>(c) Judge of probate,</u>	<u>9,572; and</u>
<u>(d) Register of probate,</u>	<u>7,778.'</u>

Further amend the Bill in section 3 in that part designated  
"§2." in subsection 1, paragraph B in the first line (same in L.D.)  
by inserting after the underlined word "counties" the following:  
' , except Penobscot County,'

Further amend the Bill in section 3 in that part designated  
"§2." in subsection 1 by inserting after paragraph B the following:

' B-1. The county treasurer in Penobscot County shall receive an  
annual salary from the county treasury, in weekly or monthly  
payments in the amount of \$5,145.'

Further amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph C, by striking out all of subparagraph (1) and inserting in its place the following:

' (1) Androscoggin, Cumberland, Kennebec and York  
Counties, \$9,100;'

Further amend the Bill in section 3 in that part designated "§2." in subsection 1, paragraph C, by adding at the end the following:

' (5) Penobscot County, \$8,375.'

Statement of Fact

The intent of this amendment is to maintain the existing salary levels in Penobscot County.
