### STATE OF MAINE

# IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-SEVEN

AN ACT to Provide for the On-premises Sale of Alcoholic Beverages By Indoor Racquet Sport Clubs.

Be it enacted by the People of the State of Maine, as follows:

- Sec. 1. 28 MRSA § 2, sub-§ 8, ¶ I, as last repealed and replaced by PL 1975, c. 741, § 1, is repealed and the following enacted in its place:
  - I. Indoor racquet sport club. "Indoor racquet sport club" shall mean any commercially operated indoor facility with 4 or more courts or areas designed or used for the playing of any racquet sport which is open to the general public, which charges a fee and which has adequate facilities for the sale and consumption of alcoholic beverages. Racquet sports shall include, but are not limited to, tennis, badminton, squash and paddleball.
- Sec. 2. 28 MRSA § 701-A, sub-§ 1, ¶ I, as enacted by PL 1975, c. 741, § 22, is repealed and the following enacted in its place:
  - I. Indoor racquet sport clubs; and
