## STATE OF MAINE

### IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-SEVEN

AN ACT Establishing a Loan Fund for Volunteer Ambulance and Rescue Squads.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 32 MRSA § 77 is enacted to read:

§ 77. Volunteer Ambulance and Rescue Squad Loan Fund

The Volunteer Ambulance and Rescue Squad Loan Fund is established within the Department of Human Services as a nonlapsing, revolving loan fund for the purpose of providing loans to volunteer ambulance and rescue squads. The fund shall consist of any appropriations to the fund which the Legislature may make and all payments of principal and interest paid on any loans made pursuant to this section.

This fund shall be used to provide loans to licensed incorporated volunteer ambulance and rescue squads within the State for the purchase of equipment except vehicles by those squads or for tuition or the expense of training for members of the squads. Each loan made pursuant to this section shall carry a maximum 1% interest rate and shall be made for a period of not more than 3 years. No one ambulance or rescue squad shall receive or have outstanding any number of loans totaling more than \$1,500 at any one time. Each loan shall be made to a licensed incorporated volunteer ambulance or rescue squad and not to an individual member of the squad.

The advisory board shall approve all loans made pursuant to this section and shall promulgate all rules and regulations necessary to carry out the purposes of this section and, in cooperation with the Department of Human Services, shall administer this section.

#### Any and all expenses of the advisory board or the Department of Human Services related to this section, including administrative expenses, shall be charged to this fund.

Sec. 2. Appropriation. There is appropriated from the General Fund to the Department of Human Services the sum of \$40,000 to carry out the purposes of this Act. The breakdown shall be as follows:

### STATEMENT OF FACT

Because many volunteer ambulance and rescue squads depend solely on fund drives and donations, it is often hard to raise enough money at one time to purchase necessary or required equipment. Also, the State or Federal Government may require certain equipment or training at a time when there is no money available, but would be after the annual fund drive. This fund would be available to these volunteer squads to purchase necessary equipment or provide required training immediately.
