STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-SEVEN

AN ACT to Revise the Oil Burner Men Law.

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 20 MRSA § 2361, as repealed and replaced by PL 1975, c. 374, § 1, is amended by adding at the end the following new paragraph to read:

Applications from a vocational-technical institute for licenses shall be accompanied by a certificate of course completion of an approved course of instruction by the Department of Educational and Cultural Services and by the respective boards.

Sec. 2. 32 MRSA § 2301, sub-§ 2, last sentence, as repealed and replaced by PL 1975, c. 374, § 3, is repealed and the following enacted in its place:

Applicants for a license of this classification shall present evidence of at least one year's practical experience to the board, or applicants from a vocationaltechnical institute for licenses shall be accompanied by a certificate of course completion of an approved course of instruction by the Department of Educational and Cultural Services and by the board.

Sec. 3. 32 MRSA § 2351, 3rd § from the end, as repealed and replaced by PL 1973, c. 384, is amended to read:

The members of the board, other than state employees, shall each be allowed the sum of \$30 \$50 per day and their necessary traveling expenses for actual attendance at meetings of the board held for the purposes of examining candidates, hearings on complaints or conducting business required of the board.

Sec. 4. 32 MRSA § 2402, sub-§ 2, last ¶, as repealed and replaced by PL 1975, c. 767, § 41, is repealed and the following enacted in its place:

The board shall issue without fee, a master oil burner man license to state oil burner inspectors. The license shall be issued on date of employment and shall remain valid until termination of employment at which time may be renewed thereafter for 2-year periods without further examination, upon the payment of the proper renewal fee set forth in section 2404.

Sec. 5. 32 MRSA § 2403, 1st ¶, 1st sentence, as last repealed and replaced by PL 1973, c. 384, is amended to read:

Applicants for a master or journeyman's oil burner license shall present to the chairman executive secretary of the board a written application for examination, containing such information as the board may require, accompanied by a fee of \$5.

Sec. 6. 32 MRSA § 2404, 1st sentence, as last repealed and replaced by PL 1975, c. 767, § 42, is repealed and the following enacted in its place:

All licenses shall expire biennially on December 31st as to a master oil burner man and biennially on June 30th as to other licenses.

STATEMENT OF FACT

The purpose of this bill is to revise the oil burner men law.
