STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-SEVEN

AN ACT to Increase Probate Filing Fees.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the quick, efficient and accurate disposition of probated assets is vital to the citizenry of Maine; and

Whereas, county probate offices, which make this disposition possible are supported by counties, with the level of support being largely determined by the fees paid into those probate offices; and

Whereas, it is evident that the current fees allowed by statute are insufficient to cover the costs of operation of county probate offices; and

Whereas, it is vital that these fees be immediately increased so that the level of support received by county probate offices is sufficient to enable them to do their job; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

18 MRSA § 552, sub-§ 2, as last amended by PL 1973, c. 451, § 3, is repealed and the following enacted in its place:

2. Petition to probate. Receiving and entering each petition to probate a will, including foreign wills, and each petition for the administration of an estate, a fee to be determined by the following schedule:

In addition, the registrar shall receive a fee of 25ϕ for each heir-at-law notified, excluding the petitioner.

Emergency clause. In view of the emergency cited in the preamble, this Act shall take effect when approved.

STATEMENT OF FACT

The costs of the county probate offices should be paid for by the users of those offices. This bill increases probate filing fees to enable these offices to become self-supporting.
