COMMITTEE AMENDMENT "A" to H.P. 1085, L.D. 1309, Bill,
"AN ACT Relating to Time Limitation on Providing Written Reasons
for Termination of Employment."

Amend the Bill by striking out all of section 2 and inserting
in its place the following:

'Sec. 2. 26 MRSA §630, as enacted by PL 1975, c. 420,
is repealed and the following enacted in its place:

§630. Written statement of reason for termination of employment

An employer shall, within 10 working days of receipt of
the written request of the employee, notify that employee in
writing of the reasons for termination of his employment.

Notification by the employer shall be by certified mail.'

Statement of Fact

The purposes of this amendment are to:

1. Increase the notification time of the employer from
5 to 10 working days; and
2. Require the employer's notification to be by certified
mail.
