Amend the Bill in the title by inserting after the word
"Preference" the following: ', Marital Status, Personal
Appearance, Family Responsibilities, Source of Income, Place
of Residence or Business'

Further amend the Bill in section 1 by inserting after
the underlined word and comma "preference," in the 11th line
(10th line in L.D.) the following: 'marital status, personal
appearance, family responsibilities, source of income, place
of residence or business,'; and by inserting after the underlined
word and comma "preference," in the 15th line (13th line in L.D.)
the following: 'personal appearance, family responsibilities,
source of income, place of residence or business,'

Further amend the Bill in section 3 by inserting after the
underlined word and comma "preference," in the 6th line
(5th line in L.D.) the following: 'marital status, personal
appearance, family responsibilities, source of income, place
of residence or business,'

Further amend the Bill in section 4 by inserting after
the underlined word and comma "preference," in the 7th line
(6th line in L.D.) the following: 'marital status, personal
appearance, family responsibilities, source of income, place
of residence or business,'

Further amend the Bill in section 5 by inserting after the underlined word and comma "preference," in the 9th line (8th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 6 by inserting after the underlined word and comma "preference," in the 6th line (5th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 7 by inserting after the underlined word and comma "preference," in the 3rd & 14th lines of paragraph A (3rd & 11th in / ^{L.D.)} the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,' ; and by inserting after the underlined word and comma "preference," in the 4th & 10th lines of paragraph B (3rd & 8th in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 4th line of paragraph C (3rd line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 17th line (14th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,',' and by inserting after the underlined word and comma

"preference," in the 3rd line of subparagraph (1) of paragraph D (2nd line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 2nd line of subparagraph (2) of paragraph D (same in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 4th line of subparagraph (3) of paragraph D, (3rd line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 6th line of subparagraph (4) of paragraph D (4th line in L. D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 5th line of subparagraph (5) of paragraph D (4th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 8 by inserting after the underlined word/
and comma "preference," in the 6th line (same in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 9 by inserting after the underlined word and comma "preference," in the 2nd, 5th, 11th, 16th, 19th and 25th lines (4th, 9th, 13th, 15th and 20th in the L.D.) of the 2nd paragraph of that part designated "§4582." the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 5th, 9th, 17th, 21st and 28th lines of the 3rd paragraph (4th, 7th, 14th, 18th and 23rd in the L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 6th and 14th lines of the 4th paragraph (5th and 11th lines in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 10 by inserting after the underlined word and comma "preference," in the 11th and 22nd lines (9th and 19th lines in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 11 by inserting after the underlined word and comma "preference," in the 6th line (same in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 11 by inserting after the underlined word and comma "preference," in the 5th line of the 2nd paragraph of that part designated "§4592." (7th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'; and by inserting after the underlined word and comma "preference," in the 7th, 11th and 15th lines of the 3rd paragraph (6th, 9th and 12th lines in the L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 12 by inserting after the underlined word and comma "preference," in the 5th and 11th lines (4th and 8th lines in L.D.) the following: 'personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 13 by inserting after the underlined word and semicolon "preference;" in the 7th line (5th line in L.D.) the following: ←-----'personal appearance, family responsibilities, source of income, place of residence or business,'

Further amend the Bill in section 14 by inserting after the underlined word and comma "preference," in the 8th line (6th line in L.D.) the following: 'marital status, personal appearance, family responsibilities, source of income, place of residence or business,'

Statement of Fact

This amendment prohibits discrimination under the terms of the Human Rights Act on account of marital status, personal appearance, family responsibilities, source of income, place of residence or business.
