HOUSE AMENDMENT" G"to COMMITTEE AMENDMENT" A" to S.P. 423,
L.D. 1481, Bill, "AN ACT Establishing the Maine Student Incentive
Scholarship Program."

Amend the amendment by striking out all of the 2nd paragraph and inserting in its place the following:

'A. Have graduated from an approved Maine secondary school or successfully completed a general education development examination or its equivalent in Maine. The department is authorized to establish rules regarding the eligibility of a student who, in addition to being a resident, has had substantial ties with the State of Maine but who has not graduated from an approved Maine secondary school or successfully completed a general education development examination or its equivalent in Maine. These rules shall include consideration of the length of that student's residency and the existence of close family ties in Maine, including spouse, children, siblings, parents or grandparents who are residentes of Maine; provided, however, that the department is authorized to consider as eligible an applicant whose parents have, prior to the student's graduation or its equivalent, died, have otherwise surrendered all parental

rights or have moved away from Maine. The qualifications
of a student's guardian or other person acting in loco
parentis to the student may be substituted for that of the
parents;'

Further amend the amendment by striking out all of section 2 and inserting in its place the following:

'Sec. 2. Appropriation. There is appropriated from the General Fund to the Department of Educational and Cultural Services, Maine Student Incentive Scholarship Program, the sum of \$742,000 for the fiscal year 1978-79 to carry out the program.

It is the intent of the Legislature that any funds unexpended in this sum shall not lapse, but shall be carried forward to the following fiscal year to be expended in that year by the Department of Educational and Cultural Services solely for the same purpose.'

Statement of Fact

The purpose of this amendment to the committee amendment is to ensure that older students who have been longtime residents of Maine are not disqualified because they did not graduate from a Maine secondary school or complete its equivalent in Maine, and it ensures that the parents' death, their surrender of parental

rights or their emigration from Maine prior to the completion of a student's education, does not exclude that student from financial assistance.

The amendment also eliminates the addition of 2 new positions within the Department of Educational and Cultural Services under this Act.
