SENATE AMENDMENT "F" to H.P. 1298, L.D. 1495, Bill, "AN ACT Establishing an Experimental Open Season on Moose."

Further amend the Bill in that part designated "§2355-E." in subsection 3 in the first line (same in L.D.) by striking out the underlined word "hunting" and inserting in its place the underlined word 'slaughter'

Further amend the Bill in that part designated "§2355-E." by striking out all of subsection 4 and inserting in its place the following:

'4. Slaughter permits. The Commissioner of Inland Fisheries and Wildlife is authorized to issue not more than 600 moose slaughter permits for Units 1, 2 and 5 for the 1977 season. A valid Maine resident hunting license, in addition to a Maine moose permit, shall be required to hunt moose. Permits shall be chosen by public chance drawing. Prior to the issuance of such permits, proof of residence must be provided by all persons chosen. To be eligible for the official drawing, at which time such permits shall be drawn, it shall be necessary for an applicant to submit a written application and a fee of \$3 to the department. These

applications shall be provided by the commissioner and obtainable from resident license agents. Fees shall not be refunded. Each person selected may then choose one individual possessing a valid Maine resident hunting license to slaughter with him or her. The 2 persons, or single person, as the case may be, will receive one moose permit to be carried on the person of the permittee. The permittee may also slaughter alone if he chooses, but the selected subpermittee must always be accompanied by the permittee.

Further amend the Bill in that part designated "§2355-E." in subsection 6 in the last line (same in L.D.) by striking out the underlined word "hunting" and inserting in its place the underlined word 'slaughtering'

There shall be no charge for this permit.'

Further amend the Bill in that part designated "§2355-E." in subsection 10 in the 2nd line (same in L.D.) by striking out the underlined word "hunting" and inserting in its place the underlined word 'slaughter'

Further amend the Bill in that part designated " $\S 2355-E$." in subsection 12 in the 2nd \longrightarrow line (1st and 3rd lines in L.D.) by striking out the underlined word "hunting" and inserting in its place the underlined word 'slaughter'
