SENATE AMENDMENT "A" to SENATE AMENDMENT "A" to H.P. 1969, L.D. 2049, Bill, "AN ACT to Provide for Refunding of Municipal Claims under the Maine Tree Growth Tax Law."

Amend the Amendment by inserting after the first paragraph after the title the following:

'Sec. 1. 12 MRSA §1201, 3rd \P , as repealed and replaced by PL 1965, c. 226, §34, is amended to read:

Franklin County. Townships B.K.P., W.K.R.: 4,R.1; 3,R.3; 4,R.3, Townships W.B.K.P.: 1,R.2; 2,R.3; 3,R.3; 2,R.4; 3,R.4; 1,R.5; 2,R.5; 3,R.5; 1,R.6; 2,R.6; 3,R.6; Gore N. 2 and 3,R.6; 1,R.7; 2,R.7; 1,R.8; Gore N. 1,R.8; 2,R.8. Other townships: D; E; 6,N. of Weld; Perkins; Washington; Freeman; Salem. Municipalities: Coplin Plantation, Dallas Plantation, Rangeley Plantation, Sandy River Plantation.

Sec. 2. 12 MRSA \$1201, 6th ¶, last sentence, which relates to Penobscot County, as repealed and replaced by PL 1965, c. 226, \$34, is amended to read:

Municipalities: Medwayy Drew Plantation, Grand Falls Plantation, Lakeville Plantation, Seboeis Plantation, Webster Plantation.

Further amend the Amendment by renumbering sections 1 to 5 to be sections 3 to 7.

Further amend the amendment by inserting before section 6 the following:

'Sec. 8. P&SL 1971, c. 104, §3 is repealed as follows: Sec.-3---Town-required-to-be-a-member-of-the-Maine-Forestry SENATE AMENDMENT "A " to SENATE AMENDMENT "A " to H.P.1969, L.D. 2049

Bistrict,--After-the-effective-date-of-this-Act7-the-Town-of Carrabasset-Valley-shall-be-required-to-be-a-member-of-the-Maine Forestry-Bistrict.'

Further amend the amendment by renumbering section 6 to be section 9.

Further amend the Amendment by inserting at the end before the Statement of Fact the following:

'Sec. 10. Effective date. Sections 1 and 2 of this Act shall take effect on January 1, 1979.'

This amendment removes Medway and Carrabasset Valley from the Maine Forestry District effective January 1, 1979.
