# IN THE YEAR OF OUR LORD NINETEEN HUNDRED SEVENTY-EIGHT

AN ACT to Facilitate Recruitment and Retention of Outstanding Persons for Policy-making Positions in State Service.

Emergency preamble. Whereas, Acts of the Legislature do not become effective until 90 days after adjournment unless enacted as emergencies; and

Whereas, the salaries of certain officers in the executive branch are inadequate to attract and retain qualified individuals and this inability seriously hampers the effectiveness of State Government and causes the people of the State to suffer needless hardship; and

Whereas, in the judgment of the Legislature, these facts create an emergency within the meaning of the Constitution of Maine and require the following legislation as immediately necessary for the preservation of the public peace, health and safety; now, therefore,

Be it enacted by the People of the State of Maine, as follows:

Sec. 1. 2 MRSA § 6, sub-§ 1, 1st sentence, as last repealed and replaced by PL 1973 c. 788, § 2, is amended to read:

The salaries of the following state officials and employees to no more than  $\frac{$25,500}{$28,113}$ .

Sec. 2. 2 MRSA § 6, sub-§ 1, as last amended by PL 1975, c. 766, § 1, is further amended by adding at the end the following:

Chairman, Public Utilities Commission.

- Sec. 3. 2 MRSA § 6, sub-§ 1-A, is enacted to read:
- 1-A. The salaries of the following state officials and employees to no more than \$25,000:
- **Sec. 4.** 2 MRSA § 6, sub-§ 3, 3rd  $\P$ , as last repealed and replaced by PL 1973, c. 509, § 2, is repealed as follows:

Sec. 5. 2 MRSA § 6, sub-§ 3, as last amended by PL 1975, c. 770, § 2, is further amended by adding at the end the following:

Public Utilities Commission members, other than Chairman.

**Emergency clause.** In view of the emergency cited in the preamble, this Act shall take effect when approved.

#### STATEMENT OF FACT

This bill seeks to solve a major personnel problem in State Government: The salary that may be offered to many top state officials is very often too low to attract and retain a high caliber of individual. This is not to say that the State does not attract very capable inviduals, quite obviously, it does, but salary is a serious issue for these indivuduals. There are numerous recent cases of highly qualified inviduals not accepting offers of state employment or seriously considering leaving state employment. As a further indication of the generally low salary

level of members of the Governor's cabinet, several of them have subordinates who are paid a higher salary.

The bill raises the salary that may be paid to state officials, as follows:

This bill establishes in the Public Laws permission for the appointing authority (normally the Governor) to pay up to the higher base salaries listed above. In addition, higher salary levels may still be established in appropriation acts. This was done, for example, in Private and Special Laws of 1975, chapter 147, part D, section 7, which established a new, higher pay range for all state officials whose salaries are limited by Title 2, section 6. This bill will automatically increase the salaries of some of the officials listed in Title 2, section 6.
