SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 1942, L.D. 2108, Bill, "AN ACT to Revise the Salaries of Certain County Officers."

Amend the Amendment by inserting before section 1 the following:

'Sec. 1. 18 MRSA §262 is enacted to read:

§262. Androscoggin County register to be full time

The register of probate of Androscoggin County shall devote his entire time to the duties of his office.'

Further amend the Amendment by striking out all of section 1 and inserting in its place the following:

'Sec. 2. 30 MRSA \$2, sub-\$1, \$A, relating to ANDROSCOGGIN COUNTY, as repealed and replaced by PL 1977, c. 67, \$3, is amended to read:

R. SENATE AMENDMENT "A " to COMMITTEE AMENDMENT "A" to H.P. 1942, L.D. 2108

Further amend the Amendment by renumbering sections 2 to 14 to be sections 3 to 15.

Further amend the Amendment by inserting before section 15 the following:

'Sec. 16. 30 MRSA \$605 is enacted to read:

\$605. Androscoggin County treasurer to be full time

The treasurer of Androscoggin County shall devote his entire time to the duties of his office.

Sec. 17. 30 MRSA \$909 is enacted to read:

\$909. Androscoggin sheriff to be full time

The sheriff of Androscoggin County shall devote his entire time to the duties of his office.'

Further amend the amendment by renumbering section 15 to be section 18.

Statement of Fact

This amendment affects certain Androscoggin County officers. It increases the salary of the chairman of the county commissioner of Androscoggin County to \$5,050 and of the other county commissioners of Androscoggin County to \$4,250.
