STATE OF MAINE HOUSE OF REPRESENTATIVES 108TH LEGISLATURE SECOND REGULAR SESSION

COMMITTEE AMENDMENT "A" to H.P. 2067, L.D. 2128, Bill, "AN ACT to Readjust Disbursement of the Potato Tax Fund."

Amend the bill in section 1, subsection 1-A, by striking out all of paragraph B and inserting in its place the following:

'B. Subject to the provisions of this section, 20% of the total moneys received in any given year under section 4565 shall be paid quarterly to the Maine Potato Council which shall use those funds for improvements in the coordination of efforts to improve the potato industry, promotion of Maine potatoes and the Maine potato industry, assistance to potato farmers in improving potato farming practices and necessary administrative support to the Maine Potato Council. The council shall pay from the funds dues to the National Potato Council and any successor organization. funds remaining shall The balance of these tax/ be used in research and programs to improve the guality of potatoes.

The Commissioner of Agriculture shall promulgate Rules:

(1) Requiring the Maine Potato Council to submit to the commissioner, prior to the beginning of any fiscal year, a budget showing, for funds paid to the council under this section, actual and estimated amounts available and expended for that fiscal year and the fiscal year immediately preceding; the budget shall be a form prescribed by the commissioner and shall be available for public inspection in his office and in the office of the council; and COMMITTEE AMENDMENT "A " to H.P. 2067, L.D. 2128 Page 2.

(2) Governing the expenditure of funds paid to the council under this section for travel out of State; to the extent possible, the rule shall be identical to rules governing such travel by State employees, provided that the rule shall require that the commissioner shall have the authority to approve or disapprove for conformance to the rule all the expenditures before they are made.'

Further amend the bill by inserting at the end before the statement of fact the following:

<u>'Sec. 3.</u> Study authorized. The Commissioner of Agriculture shall conduct a study of current and alternate procedures for electing and appointing grower members to the Maine Potato Commission. In conducting the study, the commissioner shall consult with others as is appropriate, including but not limited to, the Maine Potato Commission, Maine Potato Council, Maine Potato Sales Association, Central Aroostook Young Farmers and Aroostook County Farm Bureau. The commissioner shall submit a description of the study, and any recommendations including drafts of proposed legislation, to the First Regular Session of the 109th Legislature.'

Statement of Fact

This amendment makes the following changes to L.D. 2128.

1. / Reduces, from 30% to 20% of the potato tax, the amount which shall be paid to the Maine Potato Council; language is added to clarify the intent that 20% of the "total moneys received in any given year" is to be paid to the council, which COMMITTEE AMENDMENT "A " to H.P. 2067, L.D. 2128 Page 3.

shall be in addition to the amount now available to the commission under Title 36, section 4571, subsection 4; the council is required to pay from the funds dues to the National Potato Council, the balance of remaining funds shall be used in research and programs to improve the quality of potatoes.

2. / Requires the Commissioner of Agriculture to promulgate rules requiring the council to:

A. Submit to the commissioner for information a budget for funds received under this Act:and

B. Comply with regulations of the commissioner governing out of state travel paid out of council funds made available under this Act.

Maine Note: In addition to these requirements, the/Potato Council is subject to post audit by the Department of Audit under current law, Title 5, section 243, subsection 8.

It 3. / Requires the Commissioner of Agriculture to report to First Regular Session of the the/109th Legislature the results of a study on current and alternate methods of appointing and electing grower members of the Maine Potato Commission.
