SENATE AMENDMENT "B " to H.P. 2096, L.D. 2139, Bill,  
"AN ACT Relating to Appropriating Funds for Certain Municipal  
Governments."

Amend the bill by striking out everything after the  
enacting clause and inserting in its place the following:

'Appropriations for necessary expenditures of certain  
municipal governments. In order to provide assistance for  
some of the necessary expenditures of certain municipal  
governments, an amount not to exceed the amounts listed below,  
or an equal proration if sufficient funds are not available,  
shall be expended from any balances available in the general  
purpose aid for local schools from the fiscal year 1979  
appropriations. The sums shall be paid by the Treasurer of State  
not later than April 1, 1979.
